No. 4/RO/SDO/PSI/12-GEN/ELEC/NOTICE/2022: In pursuance of Section 31 of the Representation of the people Act, 1951 read with Rule 3 of the conduct of Election Rules, 1961 and further in pursuance of Election Commissioner of India's Notification No. 464/MR-LA/2022 dated 1<sup>st</sup> February, 2022 and Secretariat: Election Department's Notification No. AA-102/1/2021-ELEC-ED dated 1<sup>st</sup> February, 2022 read with Chief Electoral Officer, Manipur's Notification No. AA-102/1/2021-ELEC-ED(1) and No. AA-102/1/2021-ELEC-ED(II) dated 1<sup>st</sup> February, 2022 issued by the Chief Electoral Officer, Manipur, notice is hereby given that :

1. An election is to be held of a member to the Manipur Legislative Assembly in the 19-Patsoi Assembly Constituency.
2. Nomination paper may be delivered by a candidate or by any of his proposers to the Returning Officer or to Km. Ksh. Renu Devi, Sub-Deputy Collector (Patsoi)/ Assistant Returning officer of 19-Patsoi Assembly Constituency at the office of the Returning Officer/SDO (Patsoi), (DC, Imphal West, Office Complex, Lamphelpat) between 11 A.M. and 3 P.M. on any day (other than public Holiday) not later than the **8<sup>th</sup> February, 2022**.
3. Forms of nomination paper may be obtained at the place and time aforesaid.
4. The nomination papers will be taken up for Scrutiny at 11 A.M. on the **9<sup>th</sup> February, 2022**, at the office of the Returning Officer/SDO (Patsoi), DC (I/W) Office Complex, Lamphelpat.

5. Notice of withdrawal of candidature may be delivered either by a candidate or by any of his proposers or by his election agents who has been authorized in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above at his office before 3 P.M. on the **11<sup>th</sup> February, 2022**.
6. In the event of the election being contested, the poll will be taken on the **27<sup>th</sup> February, 2022** between the hours of 7 A.M. and 4.00 P.M.
