No. DC(IE)/9/913/2020(Pt.) : In pursuance of the Government approval conveyed vide letter No. LDM-101/124/2021-REV-REVENUE dated 3rd January, 2022 the under mentioned 14 (fourteen) persons are hereby allotted the piece of land as indicated against their name for agricultural purpose at village No. 1-Sinam under Section 14(1) of the MLR & LR Act, 1960 read with Rule, 15 of the MLR & LR (Allotment of Land Rules), 1962 subject to the following conditions:-

- 1) The allotment is made subject to the provisions under Rules 15 of the MLR & LR (Allotment of Land Rules), 1962.
- 2) The allottees shall pay premium amount as fixed by the Deputy Commissioner after obtaining approval from Government through Challan and credit the same to Major Head-0029-Land Revenue, on behalf of the Deputy Commissioner, Imphal East within 2(two) months and a copy each of the Challan shall be furnished to the undersigned and Sub-Divisional Officer, Sawombung
- 3) The allottees shall pay land Revenue as assessed by the competent authority under MLR & LR 1960.
- 4) The allottees shall execute Deed of Allotment with the Deputy Commissioner, Imphal East on production of Challan copy for payment of premium.
- 5) The land shall not transferred by the allottee within ten years on the date of allotment without the written consent of the deputy commissioner;
Provided that the land may be mortgaged to a co-operative Society, a co-operative bank or land mortgage bank or the Government(or a statutory body) without such consent.
- 6) An allottee on giving three months notice before the end of an agricultural year and on payment of all Government dues in respect of the allotted land up to the end of the said agricultural year may surrender the land allotted to him. On such surrender being made, the land shall revert to the Government.
- 7) The allottee shall be liable to pay such amount as land revenue as may be assessed under the Act and the rules made hereunder.
- 8) The allotment shall be liable to be cancelled if, except in case of failing under clause iv, of Rule, 15 of the MLR & LR (Allotment of Land Rules), 1962 the land is not used within 2 years of the date of allotment for the purpose for which it was allotted or if the allottee commits a breach of any of the conditions of allotment or the provisions of these rules and the Deputy Commissioner may re-enter on the land;
Provided that no such cancellation or re-entry shall be made unless the allottee is given a reasonable opportunity of being heard.
- 9) No compensation shall be payable by the Government on account of cancellation of any allotment or of any re-entry by Deputy Commissioner under these rules, but if the allottee build any construction on the land he shall be allowed a reasonable opportunity to remove the same.
