No. AS-101/5/2021- EDN(S)-EDN(S): Under Section 18 of the Right of Children to Free and Compulsory Education Act, 2009 and under the Manipur Non Government Schools and Colleges Recognition Rules, 1975, the Governor of Manipur is pleased to grant provisional recognition up to Class I - VIII in respect of Mount Olive School, Tangmual, Village, Churachandpur District, Manipur, and for affiliation to the Board of Secondary Education, Manipur, from the academic session 2022 - 2023, subject to the condition that the School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009, the Right of Children to Free and Compulsory Education Rules, 2010 and the Manipur Non-Government School and Colleges Recognition Rules, 1975.

Further, the school shall ensure that the provisional recognition is renewed on expiry of 2(two) years from the date of issue.

- The Governor of Manipur is further pleased to order conversion of the so taken over Imphal
 Art College into full-fledged Government College under the Department of Art & Culture,
 Government of Manipur. The functioning of the Governing Body of the Imphal Art College shall stand
 closed/abolished henceforth.
- 3. The Governor of Manipur is further pleased to order creation of two of Junior Lecturer(Graphic) in the pay scale of Rs.5200-20200+2800 and regularization of the following 4 (four) contractual staffs:-

- 4. The Governor of Manipur is further pleased to order to the implementation of Manipur Services (Revised Pay) Rules, 2019 to the employees of the Imphal Art College under Art & Culture Department subject to the following conditions:
 - Revision of pay shall be made effective prospectively from the 1st day of the following month in which Cabinet approval is obtained without notional effect i.e. 01.01.2022;
 - (ii) Available of fund in the Budget provision for payment of salary;
 - (iii) Pay fixation/regulation shall be as per Finance Department's instructions/OM/Orders in this regard from time to time;
 - (iv) The College shall follow the Govt. orders/instructions issued from time to time regarding appointment/promotion/creation of posts/financial discipline and administrative matters;
 - (v) Actual payment/drawal shall be made after obtaining clearance of MIS for GIA-SIN Nos. of the respective employees.
- 5. The Governor of Manipur is further pleased to order to the protection of the past service and pay protection with notional effect including the extension of all the facilities like medical reimbursement, leave encashment, 7th pay etc. granted to regular employees of the State Government to the employees of Imphal Art College on its absorption into a Government College and also the extension of Old Pension Scheme to all its employees who were appointed to service before 01/01/2005 and New Pension scheme for those appointed from 01/01/2005.

- 6. The Governor of Manipur is further pleased to order that all the existing visiting teachers and casual daily wages (enclosed at Annexure II) of Imphal Art College shall also be allowed to continue as per requirement.
- 7. Consequent upon the taking over by the Government and subsequent conversion of the Imphal Art College into full-fledged Government College under the Department of Art & Culture, Government of Manipur, the whole area of land, buildings, other infrastructure, properties/assets either movable or immovable and all the available monetary fund of any kind belonging to the Imphal Art College shall be deemed acquired, possessed, and owned by the Department of Art & Culture, Government of Manipur.
- This issues with the approval of Cabinet decision taken on 23.12.2021 and also with the concurrence of Finance Department (PIC), Government of Manipur vide their U.O. No.07/2022-2023/FD(PIC) dated 05.04.2022 and DP's concurrence vide their U.O. No.5/2022-23/DP dated 12.04.2022.
