NOTIFICATION

Imphal, the 3rd September, 2024

No. 1/11/2Q22-FD(PIC) : In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following Rules to amend the Manipur Services (Revised Pay) Rules, 2019, namely –

1. (i) These Rules may be called the Manipur Services (Revised Pay) [8th Amendment] Rules, 2024.

(ii) The revised Pay Matrix appearing in Col.(5) of SECTION – III OF THE FIRST SCHEDULE, PART – B, to the Manipur Services (Revised Pay) Rules, 2019 in respect of certain posts are further revised and corresponding revised Pay Matrix has been prescribed as below –

 For teachers who had opted / exercised to draw pay in the AGP structure as per SCERT Department Orders vide No.7/38/97-S/SCERT, dated 14/02/2019, in order to arrive at Basic pay as on 31/12/2015, their pay on 01/01/2016 will be fixed as per the existing RoP, 2019 vide Notification No.1/10/2018-FD(PIC), dated 11th July, 2019 and is to be fixed afresh w.e.f. 01/01/2019 with the entry pay as shown below :

Fixation of pay and other conditions shall be made under the provisions of the Manipur Services (Revised Pay) Rules, 2019 issued vide Notification No.1/10/2018-FD(PIC)(Pt.1), dated 13th March, 2020, provided that they should furnish a fresh "Option Form" enclosed herewith as **Annexure-III** so as to reach the authority concerned within 3 (three) months from the date of issuance of this Notification. No further revision/ option under ROP, 2019 will be provided for teachers who opted AGP structure under State Council for Education Research & Training Department's Order No.7/38/97-S/SCERT, dated14/02/2019.

The fixation of pay on 01/01/2016 will be done as per the existing pay level at Col. (3) and further refixed on 01/01/2019 under Col. (4) i.e. the date of introduction of AGP to the employees of SCERT vide Order No.7/38/97-S/SCERT, dated 14/02/2019.

- 3. All the rules and regulations, instructions relating to pay and allowances, pensionary benefits and others etc. issued by Finance Department (Pay Implementation Cell) shall be followed.
- 4. i. These Rules shall be deemed to have some into force notionally w.e.f. 01/01/2016, actual implementation w.e.f. 01/04/2019 and cash payment from 01/08/2024.
 - ii. Arrears for the period from 01/04/2019 to 31/07/2024 shall be deposited into the respective GPF Accounts of the employees. Arrear amount deposited into GPF accounts shall be kept frozen for 3 (three) years or till retirement, whichever is earlier.
 - iii. However, for those employees covered under the New Pension Scheme (now renamed as National Pension System), arrears shall be released in 3 (three) equal installments:
 - a. 1st installment w.e.f. 1st October, 2024
 - b. 2nd installment w.e.f. 1st October, 2025
 - c. 3rd installment w.e.f. 1st October, 2026
 - iv. Arrears for the expired / retired employees shall be paid in one-time installment.

v. The calculation of arrears for the period from 01/04/2019 to 31/03/2020 shall be made as per Finance Department (PIC)'s order No.1/10/2018-FD(PIC), dated 31st July, 2019.
