No. FX-8/13/2022-e-FD-Part(2): In exercise of the powers conferred under Section 21 of the Eastern Bengal & Assam Excise Act, 1910 (Act 1 of 1910) as extended to Manipur and in supersession of all previous orders of this Government, the Governor of Manipur is pleased to order that the rates of Excise duty on different types of liquor for all categories (Civilian, Army/ Para-military etc.) shall be levied as per details in Annexure-I.

2. This notification shall come into force from the date of its publication in the Official Gazette of Manipur.
