<u>NOTIFICATION</u> Imphal, the 17th December, 2024

No. 1/39/19-RR(AC)/DP: In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following Rules regulating the method of recruitment to the post of Editor (Art & Culture) in the Department of Art & Culture, Manipur as shown in the M.P.S.C. Form-8, namely :-

- 1. Short title:- These Rules may be called the Editor (Art & Culture) Recruitment Rules, 2024.
- 2. **Application:-** These Rules shall apply to the post specified in column 1 of the M.P.S.C. Form-8 hereto annexed.
- 3. Classification, Scale of pay, method of recruitment etc.:- Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in the columns 3 to 13 of the said MPSC Form-8.
- 4. **Disgualifications :-**

(a) No person, who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the aforesaid post, and

(b) No woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said post.

Provided that the Governor of Manipur may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

- 5. "Power to relax - Where the Governor is of opinion that it is necessary or expedient so to do, he may order, for reasons to be recorded in writing and in consultation with the Department of Personnel & Administrative Reforms (Personnel Division), Government of Manipur for relaxation of any of the provisions of these rules with respect to any class or category of persons or posts."
- These rules shall come into force with effect from the date of publication in the Manipur 6. Gazette.

4.	Scale of pay	Level-8 Rs. 9300 - 34800 + GP Rs. 4300/- Rs. 9300-34800 + GP Rs. 4400/- After 10 years regular service in the Grade. [As prescribed in post creation order No. 1/31/2014-S(AC) dated 25-10-2016]
5.	Whether selection post or non-selection post	Selection
6.	Age for direct recruits	38 (thirty-eight) years & below (upper age limit is relaxable for Government servant appointed under the Government of Manipur to the extent of the period of continuous service put in the post/service and by 5 years for SC/ST candidates and by 3 years for OBC candidates and a Government servant who belongs to SC/ST) will get the facility admissible to a Government servant in addition to the relaxation admissible to SC/ST candidates.) Relaxation of age shall be applicable to the candidate as per Govt. orders/O.M. etc. issued from time to time.
7.	Educational and other qualifications required for direct recruits	 ESSENTIAL : Degree of a recognised University. Degree/Diploma in Journalism (duration of diploma course should not be less than one academic year) from a recognised University/Institute. DESIRABLE: Good command of English & Manipuri Language. Experience in Journalism/Publicity work under the Govt. or Publicity Organisation of standing.

8.	Whether age and educational qualification prescribed for the direct recruits will apply in the case of promotees	N.A.
9.	Period of probation, if any	2 (two) years
10.	Method of recruitment whether by direct recruitment or by promotion or by deputation/ transfer and percentage of the total sanctioned post to be filled by various methods:	By promotion failing which by direct recruitment
11.	In case of recruitment by promotion/deputation/ transfer, grades from which promotion/ deputation/transfer to be made	Promotion : Assistant Editor with 5 (five) years regular service in the Grade
