(3) Forms of nomination paper may be obtained at the place and times aforesaid;

(4) Nomination paper will be taken up for scrutiny at the office of the Returning Officer, Room No. FF-01 (DC's Room), DC Office Complex, Churachandpur on **09/02/2022** at DC Office Complex, Mini Secretariat, Churachandpur.

(5) Notice of withdrawal of candidature may be delivered either by a candidate or by any of his proposers or by his election agent [who has been authorised in writing by the candidate to deliver it] to either of the officers specified in paragraph (2) above at this office before 3 P.M. on the 11/02/2022.

(6) In the event of the election being contested, the poll will be taken on 27<sup>th</sup> February, 2022 between the hours of 7 A.M. and 4 P.M.
