No. 7(2)/16/2018-HE (Pt): Whereas, consequent upon the taking over of 6 Aided Colleges namely, (1) Biramangol College, Sawombung, (2) Kakching Khunou College, Kakching Khunou, (3) Liberal College, Luwangsangbam, (4) Mayai Lambi College, Yumnam Huidrom, (5) Standard College, Kongba & (6) Thambal Marik College, Oinam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 28.06.2018, the Administrative Department had appointed 478 (four hundred and seventy eight) numbers of teaching staff and 163 (one hundred and sixty three) numbers of non-teaching staff of the erstwhile 6 (six) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 with due concurrence of Finance Department (PIC);

2. and whereas, the aforementioned teachers namely (i) Shri Y. Uttamchand Meitei, Assistant Professor in Sociology, Standard College, Kongba (ii) Shri M. Nolendro Meitei, Assistant Professor in Zoology, Standard College, Kongba, (iii) Shri N. Phulen Singh, Assistant Professor in Physics, Standard College, Kongba, (iv) Smt. S. Romee Devi, Assistant Professor in Commerce, Biramangol College, Sawombung & (v) Smt. Loitongbam Romee, Assistant Professor in Anthropology, Biramangol College, Sawombung have been appointed vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 with due concurrence of Finance Department (PIC) under the category Unqualified (Un-approved) Staff as 'Lecturer';

3. and whereas, the Additional Director, University & Higher Education, Manipur vide their letter No. DUHE-17/13/2021-DUHE-DU&HE dated 22.12.2022 had furnished a report of the Verification Committee regarding the re-verification of service records of 05 (five) teachers of Standard College, Kongba and Biramangol College, Sawombung who were initially appointed as 'Lecturer' under the category (Unqualified Un-Approved) group vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019;

4. and whereas, after careful examination, the matter was referred to Finance Department (PIC) for concurrence to the proposal of the Verification Committee and FD (PIC) has concurred to the upgradation of qualification status in connection with the appointment in respect of 5 (five) teaching staff of the aforementioned 2 (two) newly converted Government Colleges as detailed below:
