ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 27th June, 2023

No. CCs-1012/2/2021-HTE-DHTE: Whereas, the Administrative Department of Higher & Technical Education, Manipur vide Order No. CCs-1012/2/2021-HTE-DHTE(A) dated 29.07.2021 had issued order pertaining to the inclusion of 11 (eleven) teaching staff & non-teaching staff in the taking over process of the erstwhile Aided Thambal Marik College, Oinam by the Government;

2. And whereas, subsequent to the inclusion on the taking over, the Administrative Department of Higher & Technical Education, Manipur vide Order No. CCs-1012/2/2021-HTE-DHTE (B) dated 29.07.2021 had issued order for the creation of post of 11 (eleven) teaching staff & non-teaching staff of the erstwhile Aided Thambal Marik College, Oinam by the Government;

3. And whereas, the Administrative Department of Higher & Technical Education, Manipur vide Order No. CCs-1012/2/2021-HTE-DHTE dated 04.08.2021 had issued the appointment order of 7 teaching & 1 non-teaching staff;

4. And, whereas, the Directorate of University & Higher Education, Manipur vide letter DUHE-17/6/2022-DUHE-DU&HE dated 24.08.2022 had furnished the verification report of the Verification Committee in connection with service protection in respect of 4 (four) teaching & 1 (one) non-teaching staff of Thambal Marik College, Oinam mentioned at table below and recommended that the past service and pay including pension and gratuity benefit in respect of the incumbents may also be protected with effect from their initial dates of joining as per provisions under clause 7 of Manipur Civil Service (Appointment and Other Service Conditions of employees of Government Aided/Private Institutions taken over by the Government) Rules, 1981;

Details of the 4 (four) teaching & 1 (one) non-teaching staff are reflected below:

5. And, whereas, the Administrative Department of Higher & Technical Education, Government of Manipur had sought the views of Finance Department (PIC) and views of the Finance Department (PIC) is reproduced below:

"FD (PIC) agrees to the rectification / correction to the effective date of consequent admissible financial benefits and service / pay protection in respect of 4 (four) teaching and 1 (one) non-teaching staff of Thambal Marik College, Oinam in the following manner-

- i. *"Salary and allowances of all the 4(four) teaching & 1(one) non-teaching staff of Thambal Marik College, Oinam will be paid at the rate already drawn by her under the superseded Governing Body w.e.f. the date of taking over of the College till a day before the creation of post(s). Actual pay or consequent admissible financial benefits to the newly appointed Assistant Professors/ Lecturers/ Peon on regular basis shall be made w.e.f. the date of post creation and the effective date of appointment shall be considered from the date of issue of post creation order".*
- ii. *"No arrear of Pay for the period from the date of her initial date of joining as furnished by the Verification Committee up to a day before the creation of post shall be claimed/paid".*
- iii. *"Protection of the past service and pay protection with notional effect including pension and gratuity benefit in respect of 4(four) teaching & 1(one) non-teaching staff of Thambal Marik College, Oinam, the same of which will be counted as experience or service required for promotion or direct recruitment as the case may be from the date(s) of their joining. Further, the provisions of the National Pension System shall be applicable to those employees of the colleges who have been appointed after 01.01.2005 by the then Governing Body".*
- iv. *"Their appointment in Government service shall be subject to the final absorption into their respective grades in accordance with the recommendation of the M.P.S.C., Imphal pertaining to the suitability of the their appointments, service conditions and inter-se-seniority in the concerned grades".*

6. Now, therefore, in continuation of Government Order No. CCs-1012/2/2021-HTE-DHTE dated 04.08.2021, the Governor of Manipur is pleased to order the effective date of consequent admissible financial benefits and service/pay protection as concurred by the Finance Department (PIC) in respect of 4 (four) teaching & 1 (one) non-teaching staff of Thambal Marik College, Oinam as detailed in para 5 above.

7. This issues with the concurrence of Finance Department (PIC) vide their **U.O. No. 27/2023-2024/FD(PIC) dated 28/04/2023.**
