THE MANIPUR APPROPRIATION (No. 1) BILL, 2022

(As introduced in the Legislative Assembly, Manipur)

A BILL

to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Manipur for the services of the financial year, 2021 - 22.

Be it enacted by the Legislature of Manipur in the Seventy Third Year of the Republic of India as follows:-

 This Act may be called the Manipur Appropriation (No.1) Act, 2022.

Short Title

2. From and out of the Consolidated Fund of the State of Manipur there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of nine thousand one crore ninety two lakh twelve thousand rupees towards defraying the several charges which will come in course of payment during the financial year 2021 - 22 in respect of the services specified in column 2 of the Schedule.

Issue of Rupees 9001,92,12,000 from and out of the Consolidated Fund of the State of Manipur for the financial year 2021 - 22

3. The sum authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
