**No. UHE-18030/1/2022-HTE-DHTE:** Whereas, consequent upon the taking over of 4 (four) Aided Colleges vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 29.01.2020 and inclusion of the 105 (teaching & non-teaching staff in the taking over process of erstwhile Aided 4 (four) Colleges namely, i) Moreh College, Moreh ii) S. Kula Women's College, Nambol, iii) South East Manipur College, Komlathabi & iv) Waikhom Mani Girls' College, Thoubal by the Government, the Administrative Department of Higher & Technical Education, Manipur vide Order No. 14(9)/25/2019-HE(4 Aided) dated 15.04.2021 & No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.) dated 02.08.2021 had appointed i) Thounaojam Shyamo Singh of Waikhom Mani Girls' College as 'Lecturer in Geography' & ii) Nongmaithem Brojendro Singh of S. Kula Women's College as 'Lecturer in Physics' respectively under the category 'Unqualified (Unapproved) staff' as per the Verification report of the Verification Committee and with due concurrence of FD(PIC);

2. and whereas, the Director (Univ. & Hr. Edn.), Manipur vide letter No. DUHE-17/10/2022-DUHE-DU&HE dated 28.03.2022 had furnished the re-verification report of the Verification Committee in respect of the aforementioned 2 teaching staff of erstwhile Aided College and recommended the said staff to be appointed as 'Assistant Professor' in their respective subject;
