ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 8th January, 2022

No.14(9)/17/2021-HE(Supernumerary) : Whereas, consequent upon the inclusion of 105 (one hundred and five) left out teaching & non-teaching staff in the taking over process of 4 (four) Aided Colleges namely, 1) Moreh College (MC), Moreh, (2) S. Kula Women's College (SKWC), Nambol, (3) South East Manipur College (SEMC), Komlathabi and (4) Waikhom Mani Girls' College (WMGC), Thoubal, necessary verification had been completed and post creation for 61 (sixty one) teaching & 44 (forty four) non-teaching staff was issued vide order No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.)(B) dated 22.06.2021. The aforementioned post creation order was issued with the concurrence of Finance Department (PIC) U.O. No. 337/2020-2021/FD(PIC) dated 09.03.2021;

2. and whereas, the Administrative Department of Higher & Technical Education, Manipur had appointed 21 (twenty one) number of teaching staff in their respective subjects & Colleges as 'Lecturer' under the category 'Unqualified (Unapproved)' in the pay scale of Rs. 9300-34800 + GP Rs. 4400/-, against the post of 'Assistant Professor' created vide the aforementioned Post creation order dated 02.08.2021, as concurred by Finance Department (PIC) till such time they qualify as per relevant RRs of UGC and were also provided with an opportunity to acquire the necessary minimum qualification as per relevant UGC norms within a period of 5 years. Details of the 21 Lecturers are provided in **Annexure-I**.

3. and whereas, the Administrative Department of Higher & Technical Education, Manipur received a letter No. 3/3-36/15-UHE(Pt. II)(Vol. IV) dated 16.09.2021 wherein the Director (Univ. & Hr. Edn.), Manipur had furnished a proceeding of the Verification Committee requesting to create 21 supernumerary posts of Lecturer so as to fit the same number of unqualified teachers as done in earlier similarly situated cases;

4. and whereas, the views of Finance Department (PIC), Government of Manipur was obtained as cited below:

"Administrative Department is advised to place the matter before the Cabinet with the following conditions -

- i) To freeze the 21 nos. of newly created posts of Assistant Prof. in the EIN for the time being;*
- ii) To create 21 (twenty one) nos. of supernumerary post of Lecturers in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- and fit the unqualified teachers in the newly created posts;*
- iii) On possessing the requisite educational qualification for the post of Assistant Prof., the said Lecturers may be upgraded to the post of Assistant Prof., and the post of Lecturers held by him/her abolished."*

5. and whereas, views of Department of Personnel was also obtained and DP had advised the Administrative Department to *“place the matter for creation of supernumerary post of 21 Lecturers before Committee of Officers as was done earlier for 80 supernumerary posts and to take both the matter together to Cabinet for considered decision”*;

6. and whereas, the matter was placed before the Committee headed by Chief Secretary, Government of Manipur and had advised the Administrative Department *“to place the proposal for creation of 21 supernumerary posts of Lecturers to accommodate the unqualified teachers of 4 erstwhile Aided Colleges namely (i) Moreh College (2) S. Kula Women’s College (3) South East Manipur College and (4) Waikhom Mani Girls’ College before the State Cabinet for taking a considered decision”*;

7. and whereas, the State Cabinet in its sitting held on 04.01.2022 had approved the following:

- i) To freeze the 21 nos. of newly created posts of Assistant Professor in the EIN for the time being;
- ii) To create 21 nos. of supernumerary post of Lecturers in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- and fit the unqualified teachers in the newly created posts;
- iii) Upgradation of the said Lecturers to Assistant Professor after acquiring the requisite education qualification for the post of Assistant Professor and thereafter, abolish the post of Lecturers held by them.

8. And whereas, the views of Finance Department, Government of Manipur was obtained as cited below:

“As approved by the Cabinet in its decision taken on 04/01/2022, FD (PIC) allots U.O. No. 316/2021-2022/FD(PIC), dated 08/01/2022 to the following:

- i. *To freeze the 21 (twenty one) nos. of newly created posts of Assistant Professor in the EIN for the time being;*
- ii. *To create 21 (twenty one) nos. of supernumerary post of Lecturers in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- and fit the unqualified teachers in the newly created posts*
- iii. *On possessing the requisite educational qualification for the post of Assistant Prof., the said Lecturers may be upgraded to the post of Assistant Prof., and the post of Lecturers held by him/her abolished.”*

9. And whereas, the views of Department of Personnel, Government of Manipur was obtained as also cited below:

“ DP concurs to the proposal of Higher Education Department for Higher & Technical Education Department has asked for DP’s concurrence for creation of 21 (twenty-one) numbers of supernumerary post in lieu of 21 teaching staff appointed as ‘Lecturers’ who were initially left out in the Cabinet decision taken on 28.03.2018 in respect of erstwhile Aided 4 Colleges, namely (i) Moreh College (MC), Moreh, (2) S. Kula Women’s College (SKWC), Nambol, (3) South East Manipur College (SEMC), Komlathabi and (4) Waikhom Mani Girls’ College (WMGC), Thoubal as approved by the State Cabinet approved para 10 of the Cabinet Memorandum which is reproduced below for ready reference:

- i. *To freeze the 21 (twenty one) nos. of newly created posts of Assistant Professor in the EIN for the time being;*
- ii. *To create 21 (twenty one) nos. of supernumerary post of Lecturers in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- and fit the unqualified teachers in the newly created posts;*
- iii. *On possessing the requisite educational qualification for the post of Assistant Prof., the said Lecturers may be upgraded to the post of Assistant Prof., and the post of Lecturers held by him/her abolished.”*

10. Now therefore, the Governor of Manipur is pleased to order the creation of 21 (twenty-one) supernumerary post of 'Lecturer' to fit the unqualified (unapproved) teachers (**Details listed at Annexure I**) in the newly created posts in respect of the aforementioned 4 (four) erstwhile Aided Colleges:

- i) To freeze the 21 nos. of newly created posts of Assistant Professor in the EIN for the time being;
- ii) Upgradation of the said Lecturers to Assistant Professor after acquiring the requisite educational qualification for the post of Assistant Professor and thereafter, abolish the post of Lecturers held by them.

12. This issues with the concurrence of Department of Personnel, Government of Manipur vide their U.O. No.106(T)/2021-2022/DP dated 07.01.2022 and Finance Department (PIC), Government of Manipur vide their U.O No.316/2021-2022/FD(PIC) dated 08.01.2022.
