No. 8/1/2008-AG/L: The Governor of Manipur is pleased to revise the fees /remuneration of the Advocate General, Manipur as given below:-

1.	Retaining fee per month	Rs.30,000/-
2.	Fee for appearance before the Gauhati High Court, Imphal Bench, Imphal in cases on behalf of the State Government/ State Officials per day.	Rs. 5,000/-
3.	Fee for appearance before the Supreme Court / in other High Courts including other Benches and Principal Bench of the Gauhati High Court on behalf of the State Government/ State Officials per day.	Rs.10,000/-
4.	Fee for appearance before a Tribunal or Enquiry Commission or any other Court per day.	Rs. 5,000/-
5.	(i) Fee for preparation and / or settlement of one written statement / affidavit / reply affidavit/ Misc Application for condonation of delay or any other Misc. Application.  (ii) Fee for preparation and / or settlement of Writ Petition/ Special Leave Petition / Review petition/ Memo of Appeal / in analogous cases from one judgment.	(i) Rs.2000/-  (ii) One case: Rs.5000/- subject to a ceiling of Rs.10,000/-
6.	For giving written opinion / advice in cases referred to the Advocate General per case / matter.	Rs.5,000/-
7.	Where the Advocate General is called upon to perform any other duty other than those referred above, such as acting as Arbitrator or giving opinion after hearing both sides, one being the Govt. of Manipur or performing any duty under any statute etc.	To be determined by the State Government.
8.	A daily fee of Rs. 3,000/- shall be payable to the Advocate General for the days of his absence from the headquarters in connection with appearance in the Supreme Court or any High Court, or Tribunal or a Commission of Inquiry or an Arbitrator or for any outstation tour on official duty, including the days of departure from intervening holidays and arrival back at the headquarters, but no fee shall be paid for the days of departure if he leaves the headquarters after court hours or for the day of arrival if he arrives at the headquarters before court hours.	Rs.3,000/-

2. The expenditure is debitable under Major head 2014-Admn.of Justice (NP), 114- Legal Advisors and Counsels,01-Advocate General's Office,28- Professional Services under Demand No. 26.

3. All orders conveying sanction to expenditure under the above items shall be communicated to the Finance and Law Department.
