No. 1/2/2001-FD(EXP): In exercise of the powers conferred by Clause (3) of Article 166 of the Constitution, the State Government hereby makes further amendment to the **'Delegation of Financial Powers Rules, 1995'** of the Government of Manipur, namely:-

No. 71.

Page 19 of the **'Delegation of Financial Powers Rules 1995'**
as incorporated in the Manual of Financial Procedures, 1999;

New Item shall be inserted after Item No. 8(9) in Schedule-I (Powers delegated to **GOVERNMENT DEPARTMENTS**) as follows:-

8(10)	1) Sanction of pay/wages/ remuneration under Non-Salary budgetary provision under Non Plan and State Plan in respect of contractual casual staff.	Full Power	Subject to— 1. Availability of funds under the relevant Heads of Accounts including necessary authorisation of funds in case of CSS/ CPS. 2. Initial engagement/appointment on contractual/casual basis as approved by Cabinet on recommendation of Committee of Officers constituted for this purpose by FD(PIC) and further extension of the engagement is made with prior concurrence of FD(PIC). 3. Rates of consolidated pay/wages/remuneration are as per the rates prescribed and approved by FD(PIC).

Sanction Order should incorporate the relevant Heads of Accounts, earmarked amount for this purpose, amount spent so far and available balance as on date of sanction order.</p> <p>5. Sanction order should have Annexure containing details of the contractual employees, amount sanctioned for each staff etc.</p> <p>6. Sanction order should invariably incorporate the relevant U.O. No. of FD(PIC) for initial engagement or extension of engagement, as the case may be.</p> <p>7. For contractual staff paid from CSS/CPS, the period of engagement should be within the Scheme/Programme period and payment is subject to above conditions.</p> <p>8. Drawal of funds for the above purpose is in accordance with relevant instructions issued by Finance Department in respect of encashment/letter of credit etc.</p>
