- (2) nomination papers may be delivered by a candidate or by any of his proposer to the Returning Officer or to the Assistant Returning Officer at the Camp Office of the Sub-Divisional Officer, Wangoi at the Office Complex of the Deputy Commissioner, Imphal West, Lamphelpat between 11 A.M. and 3 P.M. on any day (other than Public holiday) not later than 03-08-2012 (Friday).
- (3) forms of nomination paper and information regarding reservation of SC/ST/Women etc. may be obtained at the place and time aforesaid.
- (4) the nomination paper will be taken up for scrutiny on 04-08-2012 (Saturday) at 10 A.M. at my camp office.

- (5) notice of withdrawal of candidature may be delivered either by a candidate or by his election agent who has been authorized in writing by the candidate to deliver it to either of the officer specified in paragraph (2) above at my camp office before 3 P.M. on 07-08-2012 (Tuesday); and
- in the event of the election being contested the poll will be taken on 13-09-2012 (Thursday) between the hours of 7 A.M. and 4 P.M.
