PUBLIC NOTICE OF ELECTION

No. 7/2/SDO/RO/KBT/2012.-In pursuance of Rule 4 of the Manipur Panchayati Raj (Election) Rules, 1995, notice is hereby given that:

- (1) Elections are to be held for election of :
 - (a) Members of Imphal East Zilla Parishad from 12-Bamonkampu, 15-Keirao Makting, 16-Tulihal and 17-Changamdabi Zilla Parishad Constituencies; and
 - (b) Pradhans and Members of 12/7-Bamonkampu, 12/8- Keirao, 12/9-Chanam Sandrok, 15/17-Keirao Makting, 15/18-Kiyamgei Muslim Arapti, 15/19-Kiyamgei, 16/20-Tulihal, 16/21-Angtha, 16/22-Top Chingtha, 17/23-Changamdabi, 17/24-Yambem and 17/25-Tumukhong Moirangpurel Gram Panchayats;
- (2) Nomination papers may be delivered by a candidate or by any of his proposers to the Returning Officer at Office of the Sub-Divisional Officer, Keirao Bitra (Deputy Commissioner, Imphal East Office Complex, Porompat) between 11 A.M. and 3 P.M. on any day (other than public holiday) not later than 03-08-2012 (Friday).
- (3) Forms of nomination paper and information regarding reservation of SC, ST, Women etc. may be obtained at the place and time aforesaid;
- (4) The nomination papers will be taken up for scrutiny on 04-08-2012 (Saturday) at 11 A.M. at the Office of the Returning Officer/Sub-Divisional Officer, Keirao Bitra (Deputy Commissioner, Imphal East Office Complex, Porompat).

- (5) Notice of withdrawal of candidature may be delivered either by a candidate or by his election agent who has been authorized in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above at his/her office before 3 P.M. on 07-08-2012 (Tuesday); and
- (6) In the event of the election being contested the poll will be taken on 13-09-2012 (Thursday) between the hours of 7 A.M. and 4 P.M.
