No. 5/254/97-Lab(Pt-I) : In exercise of the powers conferred by sub-section (1) of Section 18 of the Building and Other Construction Workers (Regulation of Employment & Conditions of Service) Act, 1996 (Act No. 27 of 1996) and in supersession of the Government Order No. 5/254/97-Lab(Pt-I) dated 1st of July, 2010, the Governor of Manipur is pleased to reconstitute the Manipur Building and other Construction Workers' Welfare Board consisting of the following persons with immediate effect until further orders.

2. The Manipur Building and Other Construction Workers' Welfare Board shall receive, (a) cess collected under the Building and other Construction Workers' (RECS) Cess Act, 1996, (b) grants and loans etc. made by the Central/State Government, if any, (c) contribution made by the registered Building and Other Construction workers and the same shall be credited to the Manipur Building and Other Construction Workers' Welfare Fund to be created for the purpose and shall execute functions prescribed under Section 22 of the Building and Other Construction Workers (RECS) Act, 1996.

3. The pay and allowance/honorarium etc. of the Chairman and other Members shall be as fixed by the State Government from time to time.

4. The terms of the office of the Chairperson and the Members will be for three years or until further orders of the State Government whichever is earlier.
