A daily fee of Rs. 3,000/- shall be payable to the Advocate General for the days of his absence from the headquarters in connection with appearance in the Supreme Court or any High Court, or Tribunal or a Commission of Inquiry or an Arbitrator or for any outstation tour on official duty, including the days of departure from intervening holidays and arrival back at the headquarters, but no fee shall be paid for the days of departure if he leaves the headquarters after court hours or for the day of arrival if he arrives at the headquarters before court hours.
