NOTIFICATION

Imphal, the 15th December, 2012

No. 31/4/2011-IFS/DP: In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor of Manipur is pleased to make the following rules for Indian Forest Service and Manipur Forest Service Departmental examination, namely –

1. Short title and commencement -

- (1) These rules shall be called Indian Forest Service and Manipur Forest Service (Departmental Examinations) Rules, 2012.
 - (2) They shall come into force from the date of publication in the official Gazette.
- 2. **Definition** In these rules, unless the context otherwise requires
 - (i) "Government" means the State Government of Manipur;
 - (ii) "Commission" means the Manipur Public Service Commission;
 - (iii) "Examination" means Department Examination prescribed under the rules;
 - (iv) "Part" means a part of these rules.

Part 1 - General

3. Direction and condition of the examination -

- (1) The departmental examination prescribed under these rules shall be held by and under the direction of the Commission.
- (2) The question paper(s) for these examinations will be selected or prepared and assessed by and under the direction of the Commission and the results of the examinations announced under the authority of the Commission. A candidate securing 60% of the maximum marks in each of the 6(six) paper would be declared to have passed the examination.

4. Dates and times of Examinations –

- (1) Examinations will be held twice in a year usually in the months of April and September. The date and time of the examinations will be prescribed by the Commission from time to time.
- (2) The Commission however, for sufficient reasons cancel or vary the month prescribed for any examinations or hold such examination once a year only and such action of the Commission will not be called to question.
- **5.** Centers of examination The examination shall be held at Imphal or any other places within the State, if the Commission so decides.
- **6. Syllabus** The syllabus, books and subjects of examination, the maximum marks and the qualifying marks therefore and other instructions and rules relating thereto shall be as described in Part II below.

Part II - The Rules for the Departmental examination of the officers.

- 1. All Officers in Annexure I on appointment shall be required to pass the departmental examination.
- 2. All the temporary officers borne on the cadres mentioned in Annexure I or holding excadre posts notified as such from time to time shall be required to pass the departmental examination prescribed in Rule 1 above.
- 3. An officer may pass the departmental examination in all the subjects prescribed for him either in one or more than one examinations. If he passes in certain subjects in an examination, he would be exempted from these papers in subsequent examinations.
- 4. If an officer has passed the departmental examination similar to departmental examination as prescribed in Rule 1, he would be exempted from passing this examination.
- 5. If an officer has already passed the departmental examination as prescribed, while holding any other post under the Government, he shall not be required to passs that examination again.
- 6. No officer would be allowed his second increment, if he has not passed the Departmental Examination in full prescribed in the rules within 3 (three) years of his appointment; Provided that the Government, in special cases, extend the above period and allow him to get the next increment with retrospective effect after he has passed the examination.
