NOTIFICATION

Imphal, the 2nd January, 2013

No. 2/41/2011-CHA: In exercise of the powers conferred by section 32 of the Manipur (Hill Areas) District Councils Act, 1971 read with rule 45 of the Manipur (Hill Areas) District Councils Rules, 1972, the Governor of Manipur hereby makes the following rules, namely:-

- Short title & commencement:- (i) These rules may be called the Manipur (Hills Areas) District Councils (Chowkidar-cum-Peon, Class IV on contract basis) Recruitment Rules, 2012.
 - (ii) These shall come into force with effect from the date of publication in the Manipur Gazette.
- 2. **Application:-** These rules shall apply to the post specified in column 1 of the Tribal Affairs & Hills Department Form annexed as **Annexure-I** hereto.
- 3. **Classification, Scale of pay, method of engagement etc.:-** Classification of the said post, scale of pay, method of engagement and other matters connected therewith shall be as specified in the columns 3 to 12 of the said Tribal Affairs & Hills Department Form annexed as **Annexure- II** hereto.
- 4. **Disqualification:-** No person-
 - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the aforesaid post.

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for so doing, exempt any person from the operation of the rules.

- 5. "Power to relax:- Where the Governor is of the opinion that it is necessary or expedient so to do, he may order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons or posts:"
- 6. This notification is issued in consultation with (DP), Govt. of Manipur.
