2. The term of office of the Chairperson is three years commencing from the date on which his appointment under this notification is notified in the official gazette as provided under rule 5(1) of the Manipur Building and Other Construction Workers (Regulation of Employment & Conditions of Service) Rules, 2008.

3. Hon'ble M.L.As shall hold office of the member of the Committee for three years or till they remain as a member of Manipur Legislative Assembly, whichever is earlier as provided under rule 5(2) of the said Rules, 2008

4. The member nominated by the Ministry of Labour & employment, Government of India shall hold the office of member of this Committee during the period as to be specified by the said Ministry as provided under rule 5(3) of the said Rules, 2008.

5. The Chief Inspector (Labour Commissioner, Manipur) shall hold the office of member of this Committee during the period as to be specified by the State Government as provided under rule 5(3) of the said Rules, 2008.
6. Members representing workers, employers and association of architects or engineers shall hold office of member of this Committee for a period of three years commencing from the date on which their appointment is notified in the official gazette as provided under rule 5(4) of the said Rules, 2008.
7. Members appointed under this notification shall hold their respective offices till their respective successors are appointed as provided under proviso to rule 5 of the said Rules, 2008.
8. Further, under rule 11 (1)(a) of the Manipur Building and Other Construction Workers (RECS) Rules, 2008 it is to order that Shri Aleng A.S. Shimray, IAS, Special Secretary (Labour & Employment), Government of Manipur will be the Secretary of the Committee until further orders.
