### MANIPUR LEGISLATIVE ASSEMBLY SECRETARIAT

<u>N O T I F I C A T I O N</u> Imphal, the 26<sup>th</sup> February, 2011

No. 15(3)/2003-LA(E) .– In exercise of the powers conferred by Article 187 of the Consitution of India read with Rules 7 and 8 of the Manipur Legislative Assembly Secretariat(Recruitment and conditions of Service) Rules, 1972 as amended, the Speaker, Manipur Legislative Assembly hereby makes the following rules namely :-

1. SHORT TITLE & COMMENCEMENT (1) : These rules may be called Manipur Legislative Assembly Secretariat (Assistant) Recruitment Rules, 2011.

(i) They shall come into force with effect from the date of publication in the Manipur Gazette.

2. APPLICATION: (i) These rules shall apply to the post specified in column 1 of the Appendix annexed hereto.

3. CLASSIFICATION, SCALE OF PAY, METHOD OF RECRUITMENT ETC :-Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in the column 3 to 13 of the said Appendix.

- 4. DISQUALIFICATION :- No person -
  - (a) who has entered into or contracted a marriage with a person having a supouse living or.
  - (b) who having a spouse living has entered into a contracted a marriage with any person shall be eligible for appointment of the aforesaid post.

Provided that the Speaker may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of the rules.

5. POWER TO RELAX :- Where the Speaker is of the opinion that it is necessary or expedient to do so, he may hy order for reasons to be recorded in writing, and relax any of the provisions of these rules with respect to any class or category of persons or posts.
