No. 2/11/2019-Leg/L: In pursuance of rule 150 of the Rules of Procedure and Conduct of Business in Manipur Legislative Assembly, the following Bill as introduced in the Manipur Legislative Assembly, in its sitting held on February 21, 2019 is hereby published in the Manipur Gazette:

1. The Manipur Appropriation (No. 4) Bill, 2019 (Bill No. 4 of 2019);

#### **THE MANIPUR APPROPRIATION (NO. 4) BILL, 2019** (As Introduced in the Manipur Legislative Assembly on 21-02-2019)

#### A

#### BILL

to provide for the authorization of appropriation moneys out of the Consolidated Fund of the State of Manipur to meet the amounts spent on certain services during the financial year ended on the 31<sup>st</sup> day of March, 2015 in excess of the amounts as granted for those services and for that year.

Be it enacted by the Legislature of Manipur in the seventytieth year of the Republic of India as follows:-

1. This Act may be called the Manipur appropriation(No. 4) Short Title Act, 2019.

2. From and out of the Consolidated Fund of the State of Manipur, the sums specified in column 3 of the Schedule amounting in the aggregate to the sum of nineteen crore ninetysix lakh fortyeight thousand only shall be deemed to have been authorized to be paid and applied to meet the amount spent for defraying the charges in respect of the services specified in column 2 of the Schedule during the financial year ended on the 31<sup>st</sup> day of March, 2015 in excess of the amounts granted for those services and for that year.

Issue of Rupees 19,96,48,000/- from and out of the Consolidated Fund of the State of Manipur to meet certain excess expenditure for the financial year ended on the  $31^{st}$  March, 2015.

3. The sums deemed to have been authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the  $31^{st}$  day of March, 2015.

# MEMORANDUM SHOWING FINANCIAL IMPLICATION OF THE MANIPUR APPROPRIATION (No. 4) BILL, 2019

The Manipur Appropriation (No. 4) Bill, 2019 makes provisions for appropriation of a sum of Rs. 19,96,48,000/- (Rupees nineteen crore ninetysix lakh fortyeight thousand only) from and out of the Consolidated Fund of the State of Manipur to meet certain excess expenditure for the year ended on the 31<sup>st</sup> March, 2015. The various services and purposes for which the amount is sought to be appropriated have been shown in the Schedule to the Bill. The Public Accounts Committee has, in their Fiftieth Report recommended regularization of the excess expenditure amounting to Rs. 19,96,48,000/-.
