O R D E R S

Imphal, the 30th March, 2019

No. 744/SR/IW/2009: Whereas, an Association in the name and style - “**The Twenty Day-Care Kids Home**” was registered under MSR Act, 1989 within the jurisdiction of Imphal West District at Lambal bearing Registration No. 744 of 2009.

Whereas, the name of the Association - “**The Twenty Day Care Kids Home**” has been changed its names to a new one - “**The Ibudhou Koubru Committee**” with the amendment of its memorandum and regulations. A new Certificate of change of name has been issued by the authority mentioning the General Body Meeting Resolution No.6 dated, 05-12-2014.

Whereas, the new name of the Association - “**The Ibudhou Koubru Committee**” has again been changed to “**The Ibudhou Koubru Committee cum Lambal Village Authority**” under the same Registration No. 744 of 2009 with the amendment of its memorandum and regulations. A new Certificate of change of name also has been issued with reference to the General Body Meeting held on 25-09-2018, Resolution Nos. 1,2 and 3.

Whereas complaint(s) stating the objections to the changes of names from ‘**The Twenty Day Care Kids Home**’ to “**The Ibudhou Koubru Committee**” and again to “**The Ibudhou Koubru**

Committee cum Lambal Village Authority” have come up from different angles vide applications submitted by Shri Kh. Mohibabu and 26 (twenty six) others dt. 14-02-2019 and by W. Loken Singh with 17 (seventeen) others dt. 14-02-2019.

Whereas an Enquiry Committee has been instituted under Section 22 of the MSR Act, 1989 and Rule 30 of the MSR Rules - 2004 to enquire into the Constitution, Management, Financial Position and present situation of the “**Ibudhou Koubru Committee cum Lambal Village Authority**” vide order No. 744/SR/IW/2009 dated, the 20th February, 2019.

Whereas the Enquiry Committee submitted its report stating that the changes of names of the Association “**The Twenty Day Care Kids Home**” to “**The Ibdhou Koubru Committee**” and then to “**The Ibudhou Koubru Committee cum Lambal Village Authority**” has been strongly objected by the villagers of the locality and it was also reported that the amendments have been made without the consent of the public.

Moreover, it was added that the amendments of the Memorandum and the Regulations of the Association have been made without obtaining prior permission of the authorities of the Department which led to the violations of the provisions of the Section 8 of the MSR Act, 1989 and Rule No. 11 and 14 of the MSR Rules, 2004.

Whereas, a show cause notice has been issued address to the President/Secretary of “**The Ibudhou Koubru Committee cum lambal Village Authority**” to submit a statement of defence to the irregularities and violations of the provisions of the MSR Act, 1989 and Rules, 2004 and the objections to the changes of names of the original Association “The Twenty Day Care Kids Home”, Regd. No. 744 of 2009 vide intimation letter No. 744/SR/IW/2009 dated, the 11th March, 2019.

Whereas, the date of submission of the reply or statement of defence to the points as mentioned in the show cause notice has been relaxed upto 29th March, 2019 considering the holiday of the Holi Festival which celebrated for 5 days in the State of Manipur vide letter No. 744/SR/IW/2009 dated, the 26th March, 2019.

Whereas, the President/Secretary of “The Ibudhou Koubru Committee cum Lambal Village Authority” has submitted the reply or statement of defence to the points as mentioned in the “Show Cause” which has been issued on 11th March, 2019 under letter No. 744/SR/IW/2009. (Vide letter No. Nil dated, 29th March, 2019).

Whereas, the reply/statement of defence mentioned about the history of the changes of name of the Association starting from the registration of “**The Twenty Day Care Kids Home**” to “**The Ibudhou Koubru Committee**” and then to “**The Ibudhou Koubru Committee cum Lambal Village Authority**” and it is also stated that there is no jurisdiction and authority of the Deputy Registrar of Societies, Imphal West, Manipur for cancellation of the Registration of “**The Ibudhou Koubru Committee cum Lambal Village Authority**” .

Whereas, the reply/statement of defence could not make up the irregularities and shortfalls and violations of the provisions of the MSR Act, 1989 and Rules, 2004.

Considering the above mentioned facts, circumstances and vlatlons of the mandatory/ obligatory provisions of MSR Act, 1989 (Section 8) and MSR Rules, 2004 (Rule Nos. 11 and 14); I, in exercise of the powers conferred upon me under Section 23 of MSR Act, 1989 read with Rule No. 31(2) of the MSR Rules, 2004, cancel the registrations of the changes of names from "The Twenty Day Care Kids Home" to "The Ibudhou Koubru Committee" and then to "The Ibudhou Koubru Committee cum Lambal Village Authority" with immediate effect in the interest of the public.

However, this order does not effect to the registration of the original Association "**The Twenty Day Care Kids Home**" bearing Registration No. 744 of 2009.
