No. HCM/P-41/2012(A&E)/Pt./ : In exercise of the power conferred under Article 229(1) of the Constitution of India, read with Rule 6(1) and 7(8) of the "High Court of Manipur Officers and Employees Recruitment and Condition of Service (Classification, Control, Appeal and Conduct) Rules, 2020", Hon'ble the Chief Justice is pleased to appoint the following Class -II (Grade- IV) Gazetted Officers of the High Court of Manipur temporarily on promotion to the 6 (six) posts of "**Assistant Registrar**" in order of merit, in the pay scale of Rs. 9300-34800 + Grade Pay 5400/- per month plus other allowances as admissible under the Rules from time to time w.e.f. the date of assumption of charge.
