2. The appointment of the Officers shall be subject to the outcome of the cases relating to their appointment pending in the High Court.

3. They shall not claim nor be entitled to any retrospective regularization nor to any financial benefits including linking up of service for pensionary benefit etc. for the past service if any rendered by them and shall also ensure not to practice any private activities for entitlement of Non-Practicing Allowance (NPA) etc.

4. Vide DP's notification No. 33/31/2017-DP(VETY) dt. 06-12-2017 this is issued in exemption of consultation with Manipur Public Service Commission i.e. the requirement of recommendation under the Manipur Vety. & A.H. Service Rules, 1994. This is further issued with the concurrence of DP vide U.O. No. 16/2017-2018/DP dt. 6/12/2017 and also with concurrence of FD(PIC) vide U.O. No. 149/2017-2018 dt. 8/12/2017.

5. The Officers will be on probation for a period of 2 (two) years.
