**ORDERS BY THE GOVERNOR : MANIPUR**

Imphal, the 2<sup>nd</sup> August, 2021

**No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.):** In pursuance of the taking over of 105 (one hundred and five) teaching & non-teaching staff of erstwhile 4 Aided Colleges namely, i) Moreh College, Moreh ii) S. Kula Women's College, Nambol, iii) South East Manipur College, Komlathabi & iv) Waikhom Mani Girls' College, Thoubal by the Government vide Order No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.)(A) dated 22.06.2021, the Governor of Manipur is pleased to appoint 52 (fifty two) teaching & 43 (forty three) non-teaching staff of the aforementioned Colleges into Government service in their respective subject/post, as detailed in the **Annexure**, subject to the condition that their final absorption into respective grades of the concerned Government posts would be made in accordance with the recommendation of the M.P.S.C, Imphal pertaining to the suitability of their appointments, service conditions and inter-se-seniority in the concerned grades. The posts have been created vide Government Order 31/3/AIDED-COL/CONVSN/HE-16(Pt.)(B) dated 22.06.2021.

2. The appointment and other service conditions of the employees of the Government Aided Colleges taken over by the Government may be governed by the Manipur Civil Service (Appointment and other service conditions of employees of Government Aided/Private Institutions taken over by the Government) Rules, 1981 as per Notification dated 25.05.1981 issued by DP & AR (Personnel Division), Government of Manipur.

3. Salaries and allowances of all the existing staff of the College will be paid at the rate already drawn by them under the superseded Governing Body w.e.f the date of taking over of the college till the time before issuing appointment/absorption order. Actual pay or consequent admissible financial benefits to the newly appointed Assistant Professors/teaching and non-teaching staff on regular basis shall be made with w.e.f. the date of issue of appointment/absorption order. Further, the provisions of the National Pension System shall be applicable to those employees of the Colleges who have been appointed on or after 01.01.2005 by the then Governing Body.

4. All the Lecturers who were not qualified under the relevant Government College Lecturer Recruitment Rules under UGC Regulation against the created/converted post shall be treated as Lecturer and they shall be considered in the Scale of PB-2: Rs. 9300 - 34,800/- plus GP of Rs. 4400/- p.m. till they get qualified as per the existing recruitment rules by giving them one time opportunity to improve their educational qualification to pursue either NET/M. Phil/Ph. D. Degrees as the case may be, as per relevant UGC norms within a period of 5 (five) years from the date of issue of order for conversion into full-fledged as done in the case of regularisation of 418 Part-time Lecturers vide Government order No.7(2)/9/2005-S/HE(Pt. III) dated 10.05.2016. After improving themselves upto their requisite educational qualification i.e. either M. Phil or NET or Ph. D. Degrees, they shall be entitled for the pay-scale of PB-3: Rs. 15,600-39,100 plus AGP of Rs.6000/- p.m. with the designation as Assistant Professors in parity with qualified Assistant Professors.

5. The Unqualified (unapproved) non-teaching staff shall be absorbed in a pay scale one stage lower to the prescribed scale till such time they are qualified as per relevant RRs.
6. The inter-se-seniority list of the teaching/non-teaching staff so appointed as a result of taking over of the College shall be issued separately in consultation with the MPSC. Further, Orders pertaining to the protection of the past service and pay protection in respect of the aforementioned teaching & non-teaching staff shall be issued separately.
7. They shall remain at their respective place of posting until further orders.
