NOTIFICATION

Imphal, the 27th May, 2021

No. SEC-704/1/2021-RD and PR-RD&PR: In exercise of the powers conferred by section 105 of the Manipur Panchayati Raj Act, 1994 (Act No. 26 of 1994), the Governor of Manipur is pleased to make the following Rules further to amend the Manipur Panchayati Raj (Election) Rules,1995, namely:-

**The Manipur Panchayati Raj (Election)
(Third Amendment) Rules, 2021.**

1. Short title and commencement:

- (1) These rules may be called The Manipur Panchayati Raj (Election) (Third Amendment) Rules, 2021.
- (2) They shall come into force with immediate effect.

2. Amendment of rule 13:

In rule 13 of the Manipur Panchayati Raj (Election) Rules, 1995 (hereinafter referred to as the principal Rules):-

- (a) in sub-rule (a), the figures "50" and "25" shall be replaced by "1000" and "500" respectively;
- (b) in sub-rule (b), the figures "100" and "50" shall be replaced by "2000" and "1000" respectively; and
- (c) in sub-rule (c), the figures "500" and "250" shall be replaced by "10000" and "5000" respectively.

3. Amendment of rule 98:

In rule 98 of the principal Rules, the following proviso shall be inserted, namely -

"Provided that for the reservation of seats for women in the offices of the Pradhan, sub-rule (2) of rule 97 shall be strictly followed".

4. Amendment of rule 99:

In rule 99 of the principal Rules, the following proviso shall be inserted, namely -

"Provided that for the reservation of seats for women in the offices of the Adhyaksha, sub-rule (2) of rule 97 shall be strictly followed".

5. Amendment of SCHEDULE "Table-A" :

After SCHEDULE "Table-A" to the principal Rules, the following sub-para shall be inserted, namely -

"Symbol list of Serial No. 1 to 6 shall be allotted to the election of Zilla Parishad Members only, Serial No. 7,8,10,11 and 12 shall be allotted to the election of Pradhans only and Serial No. 13,14,15,16,18,19,20 and 21 shall be allotted to the election of Gram Panchayat Members only".
