- 5. The expenditure is debitable to the relevant Head of Accounts of the concerned High Court of Manipur/ District & Sessions Court under Demand No. 26-Administration of Justice.
- 6. The appointment of the above persons are provisional, subject to the production of Medical Fitness Certificate from the State Medical Board, Manipur.
- 7. The persons who are earlier employed in other establishment shall produce copy of service termination order at the time of joining.
