No. PLG2-201/29/2020-PLG-PLANNING: Pursuant to the Notification No. PLCY-302/2/2021-Cabinet dated 1<sup>st</sup> July, 2021 of the Confidential and Cabinet Department, Government of Manipur, the Governor of Manipur is pleased to re-constitute the existing **Governing Body** of the **Manipur Remote Sensing Applications Centre (MARSAC)**, an Autonomous Government Institution under Planning Department, Government of Manipur with the following Members :-

- i) Minister in-charge (Planning), Manipur - Chairman
- ii) Administrative Secretary (Planning), Government of Manipur - Member-Secretary
- iii) Director (Agriculture), Manipur - Member
- iv) Administrative Secretary (Finance), Government of Manipur or his representative not below the rank of Deputy Secretary. - Member
- v) Administrative Secretary (Sc & Tech), Government of Manipur or his representative not below the rank of Deputy Secretary. - Member
- vi) Principal Chief Conservator of Forest (PCCF), Government of Manipur or his representative. - Member
- vii) Dean, College of Agriculture, CAU, Iroisemba, Imphal. - Member

**Note:** The Governing Body may Co-opt Administrative Secretaries and Heads of Department and other officials/subject expert from concerned line Department(s) as and when required with the approval of the Chairman of General Body.

**2. The objectives and functions of the Manipur Remote Sensing Applications Centre (MARSAC) are listed below:**

- i) To promote application of Remote Sensing and Geographical Information System (GIS) in different areas such as agriculture, forestry, disaster management, water resources, mineral resources, environment and land use planning, urbanization, rural development, etc.
- ii) To act as an Nodal Agency for all Remote Sensing, Geographical Information Systems(GIS) and Global Positioning System(GPS) related works, procurement, supply & maintenance, analysing and creation of data, etc.
- iii) To develop Geo-spatial based Agriculture and Horticulture Development Information System using Space Technology;
- iv) To develop potential fishery resources information system using Remote Sensing and GIS;
- v) To assess and monitor shifting cultivation/forest fire on regular basis using space technology;
- vi) To carry out studies/preparation of large scale River Atlas/mining/geology and Hydro-Geomorphological (HGM) Maps for ground water prospecting in Manipur using Space Technology;
- vii) To take up integrated approach for the sustainable management and conservation of Wetlands of Manipur;
- viii) Application of Remote Sensing and GIS technology in Geo-tourism augmentation in Manipur;
- ix) Applications of Remote Sensing & GIS for assessment of bamboo resources in Manipur;
- x) To develop Disaster Management System of Manipur such as Flood Early Warning Systems, flood Hazard Zonation, Landslide Hazard Zonation, Earthquake Hazard Zonation, etc.
- xi) Integrated development of Land Information System for the State of Manipur using RS& GIS technology;

- xii) To identify, initiate, undertake, coordinate and implement research and development projects of interest to the State Government using Remote Sensing technology;
- xiii) To organize, implement and participate in the training programmes, seminars, workshop, symposia and lectures for the man-power engaged in the implementation of plans and projects related to the Remote Sensing Technology Applications;
- xiv) To provide information and documentation facilities in remote sensing disseminate information and furnish results of remote sensing investigations carried out by the Manipur Remote Sensing Applications Centre of the Society or any other organization in a suitable form of print, audio-visual and films;
- xv) To acquire by gift, purchase, exchange, lease, hire or otherwise any property movable or immovable and to construct, improve, alter, demolish or repair buildings, works and constructions as may be necessary or convenient for carrying out the activities of the Centre;
- xvi) To draw, accept, make and endorse for the purposes of the Centre, discount and negotiate Government of India and other promissory notes, bills of exchange, cheques or other negotiable instruments;
- xvii) To invest the funds of, or money entrusted to the Centre upon securities or in such manner as may from time to time be determined by the Government Body and from time to time to sell or transpose such investments, and
- xviii) To do all other such things as may be necessary, incidental or conducive to the attainment of all or any of the above objects, with or without collaboration of other Governments or agencies.

**3. Amended Rule 9 of the existing Rules & regulations of the MARSAC is listed below:**

The Governing Body shall consist of the following members namely:

- 9.1 The **Minister (i/c Planning)**, Manipur shall be the **Chairman of the Governing Body**.
- 9.2 The **Administrative Secretary (Planning)** shall be the **Member Secretary of the Governing Body**.
- 9.3 All Official members and members nominated by the State Government.
- 9.4 The Director (Planning) shall be the Ex-officio Member of the Governing Body.
