No. 14(9)/8/2020-HE(MSSW): Consequent upon the taking over of (1) Moreh College (MC), Moreh, (2) S. Kula Women's College (SKWC), Nambol, (3) South East Manipur College (SEMC), Komlathabi and (4) Waikhom Mani Girls' College (WMGC), Thoubal and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 28.06.2018, the Administrative Department of Higher & Technical Education had taken up necessary verification of the staff of the aforementioned Colleges; and whereas, the Finance Department (PIC) vide their U.O. No. 233/2019-2020/FD(PIC) dated 30.12.2019 had concurred for the appointment of Kh. Manao Singh, Lecturer in English of S. Kula Women's College as detailed below:

- 3. and whereas, the issue of Appointment Order in respect of Kh. Manao Singh, Lecturer in English was put on hold for want of proper verification of relating to his suspension from service for unauthorized absence of College by the then Secretary of the Governing Body, S.K. Women's College;
- 4. and whereas, the Director of University & Higher Education, Manipur vide letter No. 3/3- 36/15-UHE(Pt-II) dated 20.11.2020 had submitted the Report of the Verification Committee wherein the following is observed.
- "Shri Kh. Manao Singh was suspended by the Secretary, Governing Body, S.K. Women's College vide order no. SKW-7-2017(Expl. /Susp/term) dated 05-08-2019 for unauthorized absence from the College and Departmental Inquiry against Kh. Manao has not be completed due to Governing Body been dissolved /abolished with taking over of the College by the Government w.e. f 29-01-2020"
- 5. and whereas under Rule 10(7) of CCs(CCA) Rules has clearly mentioned that "an order of suspension made or deemed to have been made under sub-rule(1) or (2) of this rule shall not valid after a period of ninety days unless it is extended after review, for a further period before the expiry of ninety days.
- 6. Now therefore, after minute consideration and examination of the report of the Verification Committee and as per a Rule 10(7) of CCs(CCA) Rules, the Governor of Manipur is pleased to order the appointment of Kh. Manao Singh, Lecturer in English of the erstwhile Aided S. Kula Women's College, Nambol as Lecturer in English in pay scale as detailed at Para 2 above.
- 7. This order is issued in consultation with the Director (Univ. & Hr. Edn.), Manipur read with the concurrence of Finance Department (PIC) vide their U.O. No. 233/2019-2020/FD(PIC) dated 30.12.2019.
