No. 14(9)/9/2020-HE(MT): In pursuance of the State Cabinet decision taken on 21.08.2019 and taking over of 4 (four) Aided Colleges namely, 1) Moreh College (MC), Moreh, (2) S. Kula Women's College (SKWC), Nambol, (3) South East Manipur College (SEMCO), Komlathabi and (4) Waikhom Mani Girls' College (WMGC), Thoubal and their conversion into full fledged Government Colleges vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 29.01.2020, the Governor of Manipur is pleased to appoint the following 3 (three) teaching/Non-Teaching staff of the erstwhile Aided 3 Colleges namely i) S. Kula Women's College (SKWC), Nambol, ii) Waikhom Mani Girls' College (WMGC), Thoubal & iii) South East Manipur College (SEMCO) into Government service subject to the condition that their final absorption into respective grades of the concerned Government posts would be made in accordance with the recommendation of the M.P.S.C, Imphal pertaining to the suitability of their appointments, service conditions and inter-se-seniority in the concerned grades. The posts have been created vide Government Order No. 14(9)/9/2020-HE(MT) dated 12.10.2021.

- 3. Salaries and allowances of the staff of the Colleges indicated at Para 2 above will be paid at the rate already drawn by them under the superseded Governing Body w.e.f. the date of taking over of the College till the time before issuing appointment/absorption order. Actual pay or consequent admissible financial benefits to the newly appointed teaching and non-teaching staff on regular basis may be made w.e.f. the date of issue of appointment/absorption order.
- 4. However, no arrear of Pay for the period from the date of their initial date of joining upto till the time before issuing appointment/absorption order.
- 5. In regards to protection of the past service and pay protection with notional effect including pension and gratuity benefit in respect of Teaching/Non-Teaching Staff of the 3 (three) Aided Colleges, the same of which will be counted as experience or service required for promotion or direct recruitment as the case may be from the date(s) of their joining mentioned against each of the names in Column (5) of the Table above. Further, the provisions of the National Pension System shall be applicable to those employees of the Colleges who have been appointed on or after 01.01.2005 by the then Governing Body.

- 6. They shall remain at their respective place of posting until further orders.
