No. Writ/11/18/2020-HE/Case: Consequent upon the taking over of (1) Moreh College (MC), Moreh, (2) S. Kula Women's College (SKWC), Nambol, (3) South East Manipur College (SEMC), Komlathabi and (4) Waikhom Mani Girls' College (WMGC), Thoubal and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 28.06.2018, the Administrative Department of Higher & Technical Education had taken up necessary verification of the staff of the aforementioned Colleges;

2. and whereas, the Finance Department (PIC) vide their U.O. No. 233/2019-2020/FD(PIC) dated 30.12.2019 had concurred to the appointment of K. Somorjit Singh, Assistant Professor in Philosophy of S. Kula Women's College amongst other as detailed below:

3. and whereas, the issue of Appointment Order in respect of K. Somorjit Singh, Assistant Professor in Philosophy was put on hold as he was under suspension during the time the College was still an Aided College & a litigation was found pending in the High Court ;

4. and whereas, during the pendency of the issue of Appointment order, **Shri K. Somorjit Singh filed a Writ Petition being no. 569/2020 (K. Somorjit Singh – Vs- The State of Manipur &Ors.) and same was disposed of on 24-07-2021 with the direction to the state Government to consider the case of the petitioner within 2 (two) months from the date of the order to appoint him as Assistant Professor in Philosophy within 2(two) weeks thereafter, it is also clear that the Petitioner shall be entailed to back wages , if any and his seniority shall be counted from the date on which his junior has been appointed**

5. and whereas, the Director of University & Higher Education, Manipur vide letter No. 3/3- 36/15-UHE(Pt-II) had submitted the Report of the Verification Committee whereas it is stated that the matter relates to allotment and identification of 20 posts of Lecturers in S.K. Women's College when it was an Aided College. Now, the College has been taken over by the Government and all the eligible staff of the College have been appointed to the Government. The matter of dispute, thus, no longer exists. Over and above, the suspension Order of the teacher has also been cancelled /revoked;

6. Now therefore, in view the above facts and circumstances , the Governor of Manipur is pleased to order the appointment of K. Somorjit Singh, Lecturer of the erstwhile Aided S. Kula Women's College, Nambol as Assistant Professor in Philosophy in the pay scale as detailed in Para 2 above. And as regards the back wages, there is no back wages entailed after conversion of College from the Government and his seniority shall be counted from the date of on which his junior had been appointed as and when the sonority list is prepared .

7. This issued in compliance with the direction of the Hon'ble Court's order dated 27-4-2021 passed in W. P. (C) No. 569/2020 (K. Somorjit Singh – Vs- The State of Manipur &Ors.) and read with the concurrence of Finance Department (PIC) vide their U.O. No. 233/2019-2020/FD(PIC) ~~dated~~ 30.12.2019.

8. Further, on his appointment, he is posted at Lamka College, Churachanpur
