No.33/21/2021-Sc & Tch/DP: In exercise of the powers conferred by the Proviso to Clause (3) of Article 320 of the Constitution of India, the Governor of Manipur hereby makes the following regulation further to amend the Manipur Public Service Commission (Exemption from Consultation) Regulations, 1972 namely:-

1. **SHORT TITLE AND COMMENCEMENT**

- (1) These regulations may be called the Manipur Public Service Commission (Exemption from Consultation)(Amendment) Regulations, 2022.
- (2) They shall come into force with immediate effect from the date of Notification.

2. Addition of Regulation 115 – After Regulation 114 of the Manipur Public Service Commission (Exemption from Consultation) Regulations, 1972 the following regulation shall be added namely:-

“115 -It shall not be necessary to consult the Commission in regard to absorption/regularization of 2(two) Junior Mentor of Manipur Science Centre as a one-time measure.”

1. SHORT TITLE AND COMMENCEMENT

1. These Regulations may be called the Manipur Public Service Commission (Exemption from Consultation) (Amendment) Regulations, 2022.

2. They shall come into force with immediate effect from the date of Notification.

2. Addition of Regulation 109 – After Regulation 108 of the Manipur Public Service Commission (Exemption from Consultation) Regulations, 1972 the following regulation shall be added namely :-

“109 - It shall not be necessary to consult the Commission for absorption of Shri S. Somorendro Singh, Assistant Project Officer (DRDA wing) against the creation post of Programme Officer (MC) in the Department of RD & PR as a one-time measure.”
