No. MISEC-1/3/2022-OBC and SC-OBC&SC: In pursuance of Cabinet decision taken on 13/10/2022 regarding constitution of Loi Committee for examination of various claims/objection for inclusion as member of Loi community, the Governor of Manipur is pleased to constitute a Committee consisting of the following membership, terms of reference and conditions:

1. Members of the Committee:
 - i) A retired Judge of a Court not lower than District or Sessions Court or equivalent as the Chairperson, to be nominated by the Law Department in consultation with the High Court of Manipur.
 - ii) A Sociology/ Anthropology Profession from a reputed University, to be nominated by the Department of Other Backward Classes & SC.
 - iii) An official, not below the rank of Deputy Secretary, to be nominated by the Law Department.
 - iv) Director (OBC&SC) as the Member Secretary.
2. The terms of reference of the Committee are as follows:
 - i) Inquire into the various claims/ objections of Shageis/ villages for inclusion in the Loi community in the State vis-à-vis the recommendation of the Loi Committee of 1992 and the various court judgments and submit recommendation to the Government, for appropriate course of action;
 - ii) Examine the correctness of spelling, in the names of Shageis of already identified Shageis in the report of the Loi Committee of 1992;
 - iii) On basis of claims and other evidence submitted by the interested parties and any other basis that the Committee may determine, suggest suitable methodology for examining claims, in future;
 - iv) Any other matter relevant to (i), (ii) & (iii) above, as assigned by the State Government.
3. Sitting Allowance/ Honorarium:
 - i) The Chairperson shall be paid Rs. 3,000/- per sitting subject to a monthly ceiling of Rs. 60,000/- per month.
 - ii) Other members, except those who are Government employees, shall be paid Rs. 1,500/- per sitting subject to a monthly ceiling of Rs. 30,000/- per month.

4. Other Terms and Conditions:

- i) The Committee may co-opt. any State Government Officials, if required, for a set duration;
- ii) The Committee may issue notifications for any person to appear before the Committee to act as witness or to submit claims/ objections;
- iii) Office space, vehicles and other incidental expenditure shall be provided/ borne by the Directorate for Welfare of OBC&SC, Manipur, from the Office Expenditure Head. Budget provision shall be made, if necessary;
- iv) Proceedings of every sitting shall be recorded by the Member Secretary and submitted to the Government;
- v) The Committee shall submit the final report within six months from the date of notification of the formation of the Committee in the Gazette of Manipur;
