The Business of the Government of Manipur (Allocation) (17th Amendment) Rules, 2022.

1. Short title & commencement:

- These rules may be called the Business of the Government of Manipur (Allocation) (17th Amendment) Rules, 2022.
- It shall be deemed to have come into force with immediate effect.

2. Amendment of Sl. No. 30 in rule 1 (ii) of the Business of the Government of Manipur (Allocation) Rules, 2009: The Department at Sl. No. 30 is renamed as "Land Resources Department".
