No. 46/11/2021- SE (S): Under Section 18 of the Right of Children to Free and Compulsory Education Act, 2009 and under the Manipur Non Government Schools and Colleges Recognition Rules, 1975, the Governor of Manipur is pleased to grant provisional recognition up to Class- VIII in respect of **SL Arena of Learning, Kongpal Khaidem Leikai (Pong Lambi), Imphal - East, Manipur**, and for affiliation to the Board of Secondary Education, Manipur, from the academic session 2021 - 2022, subject to the condition that the School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009, the Right of Children to Free and Compulsory Education Rules, 2010 and the Manipur Non-Government School and Colleges Recognition Rules, 1975.

Further, the school shall ensure that the provisional recognition is renewed on expiry of 2(two) years from the date of issue.
