- I. Amendment of Rule 5 of the Recruitment and conditions of Service of the Chairman of the BoSEM Rules, 1979, by inserting the following after the last line,

'In case of appointment by deputation, deputation will be allowed till the age of 65 years or upto the date of retirement whichever is earlier, subject to the term of deputation as notified vide Order No.3/19/79-SE(S) dated 27/01/2000.'

- The allotment is made subject to the provision under Rule 18 of the MLR & LR ( Allotment of Land) Rules, 1962.
- The allottee shall pay the premium amount as fixed by the Deputy Commissioner after obtaining approval from Government through Challan and credit the same to Major Head-0029-Land Revenue on behalf of the Deputy Commissioner, Imphal East within 2(two) months and a copy each of the challan shall be furnished to the undersigned and Sub-Divisional Officer, Keirao-Bitra, Imphal East.
- The allottee shall pay land revenue as assessed by the competent authority under MLR & LR Act, 1960.
- The allottee shall execute deed of allotment with the Deputy Commissioner, Imphal East on production of challan copy for payment of premium.
- The land shall not transferred by the allottee within 10(ten) years on the date of allotment without the written consent of the Deputy Commissioner.

Provided that the land may be mortgaged to a Co-operative Society, Co-operative Bank or land mortgage Bank or the Government (or a statutory body) without such consent.

- An allottee on giving 3(three) month's notice between the end of an agricultural year and on payment of all Government dues in respect of the allotted land up to the end of the said agricultural year may surrender the land allotted to him. On such surrender being made, the land shall revert to the Government.
- The allottee shall be liable to pay such amount as land revenue as may be assessed under the Act and the rules make thereunder.
- The allotment shall be liable to be cancelled if, except in case of failing under clause iv, of Rule, 15 of the MLR & LR ( Allotment of Land Rules), 1962 the land is not used within 2 years of the date of allotment for the purpose for which it was allotted or if the allottee commits a breach of any of the conditions of allotment or the provision of these rules and the Deputy Commissioner may re-enter on the land.

Provided that no such cancellation or re-entry shall be made unless the allottee is given a reasonable opportunity of being heard.

9. No compensation shall be payable by the Government on account of cancellation of any allotment or of any re-entry by Deputy Commissioner under these rules, but if the allottee has built any construction on the land he shall be allowed a reasonable opportunity to remove the same.
