Bill No. 2 of 2022**THE MANIPUR APPROPRIATION (No. 2) BILL, 2022**
(As introduced in the Legislative Assembly, Manipur)A
BILL

to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Manipur for the services of the financial year, 2022 - 23.

Be it enacted by the Legislature of Manipur in the Seventy Third Year of the Republic of India as follows:-

1. This Act may be called the Manipur Appropriation (No.2) Act, 2022.

Short Title

2. From and out of the Consolidated Fund of the State of Manipur there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of Rupees eleven thousand five hundred twenty five crore ninety one lakh thirty six thousand three hundred thirty three towards defraying the several charges which will come in course of payment during the financial year 2022 - 23 in respect of the services specified in column 2 of the Schedule.

3. The sum authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

4. References to Departments in the Schedule are to such Departments as existing immediately before the 1st day of March, 2022 and shall, on or after that date be construed as references to the appropriate Departments as reconstituted from time to time.

**MEMORANDUM SHOWING FINANCIAL IMPLICATION OF THE MANIPUR
APPROPRIATION (No.2) BILL, 2022**

The Manipur Appropriation (No.2) Bill, 2022 makes provisions for appropriation of a sum of ₹ **11525,91,36,333/-** from and out of the Consolidated Fund of the State of Manipur for the year 2022-23. The various services and purposes for which the amount is sought to be appropriated have been shown in the Schedule to the Bill. Out of the above amount, a sum of ₹ **2921,74,44,000/-** represents the expenditure Charged on the Consolidated Fund and the balance of ₹ **8604,16,92,333/-** voted by the Legislative Assembly.
