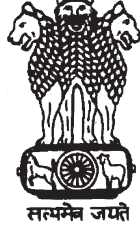

## NOTIFICATION

Imphal, the 26<sup>th</sup> March, 2021

No. C-3/173/2019-MSKA: In supersession of all previous rules issued in this regard and as per Resolution No. 5 of Executive Board meeting held on 27-02-2021, the Governor of Manipur and Chairperson, Manipur State Kala Akademi hereby makes the following rules regulating the method of recruitment to the post of **Deputy Secretary (Literature and Publication)** in the Manipur State Kala Akademi as shown in the Appendix, namely:-

1. **Short title:-**These rules may be called the Manipur State Kala Akademi [**Deputy Secretary (Literature and Publication)**] Recruitment Rules, 2021.
2. **Application:-** These rules shall apply to the post specified in column 1 of the Appendix annexed hereto.
3. **Classification, Scale of pay, method of recruitment etc.:-** Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in columns 3 to 13 of the said Appendix.
4. **Disqualification:-**
  - (a) No person, who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the aforesaid post, and
  - (b) No woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said post.

Provided that the Chairman/Chairperson, Manipur State Kala Akademi may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

5. Where the Chairman/Chairperson is of the opinion that it is necessary or expedient to do so, he/she may by order for reasons to be recorded in writing and relax any of the provisions of these rules with respect to any class or category of persons or posts.
6. These rules shall come into force with immediate effect.

3.	Classification.	Class-I/Group-A
4.	Scale of pay.	Level-12 (Rs. 53100-Rs. 167800) [As prescribed in Manipur Services (Revised Pay), Rules, 2019]
5.	Whether selection post or non-selection post.	Selection
6.	Age limit for direct recruits.	N.A.
7.	Educational and other qualifications required for direct recruits.	N.A.
8.	Whether age & educational qualification prescribed for the direct recruits will apply in the case of promotees.	N.A.
9.	Period of probation, if any.	2 (two) years
10.	Method of recruitment whether by direct recruitment or by promotion or by deputation/transfer and percentage of the vacancies to be filled by various method.	By promotion
11.	In case of recruitment by promotion/ deputation/transfer, grades from which promotion/deputation/transfer to be made.	<b>Promotion :</b> Assistant Editor with 6 (six) years regular service in the grade.
