ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 15th June, 2022

No. 31/3/AIDED-COL/CONVSN/HE-16(GIA)(B): Whereas, as approved by the State Cabinet in its sitting held on 24.11.2021 and as concurred by the Finance Department (PIC) as well as Department of Personnel, the Administrative Department of Higher & Technical Education Manipur vide Order No. 31/3/AIDED-COL/CONVSN/HE-16(GIA) dated 06.01.2022 had ordered that the appointment of 3 (three) teaching staff of erstwhile Aided Liberal College, Luwangsangbam namely, (i) M. Lokeshwar Singh (Chemistry), (ii) Dr. K. Bidyalakshmi (Education) (iii) Dr. Seromena Ashem (Home Science) in their concerned Department shall be subject to the following conditions:

- i. All salaries drawn during their service period in Education (S) Department be refunded;
- ii. Giving them past service as done for other staff of erstwhile Aided Colleges vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019.

2. and whereas, post creation order had also been issued vide Government order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 22.02.2019;

3. and whereas, the Finance Department (PIC) was moved for views/comments along with issue of UO Number so as to enable the Administrative Department of Higher & Technical Education to issue necessary order for appointment etc. and the Finance Department (PIC) has furnished the following observation:

- (a) As per Cabinet decision, Verification Committee report and AD's clarification, they may be absorbed as Assistant Professor in the scale of pay of PB: Rs. 15600-39100+AGP 6000/- in the following manner-

- (b) *The amount which have been credited in their PRAN account under New Pension Scheme shall be refunded and deposited in the appropriate Government Account in consultation with the Directorate of Treasuries & Accounts.*
- (c) *Their absorption/appointment shall be made as per the Cabinet decision taken in its decision date 24/11/2021, with past service protection as done for other staff of erstwhile Aided Liberal College, Luwangsangbam, issued vide Higher & Technical Education Department Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07/03/2019.**

4. Now, therefore in continuation of Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(GIA)(A) dated 15.06.2022, the Governor of Manipur is pleased to order the appointment of the aforementioned 3 (three) teaching staff of erstwhile Aided Colleges in their concerned Department as concurred by the Finance Department in Table at Para 3 above, with immediate effect.

5. It is further ordered that if they had opened PRAN account under the New Pension Scheme, the amount which have been credited to their PRAN Accounts shall also be refunded to the Government after due consultation with the Directorate of Treasuries & Accounts, Manipur.

6. Salaries and allowances of the aforementioned 3 (three) teaching staff of Liberal College, Luwangsangbam will be paid at the rate already drawn by them under the superseded Governing Body w.e.f the date of taking over the college till 21.02.2019 Actual pay or consequent admissible financial benefits to the newly appointed Assistant Professors/ Lecturers on regular basis shall be made with w.e.f. 22.02.2019.

7. Further, protection of the past service and pay protection with notional effect including pension and gratuity benefit in respect of aforementioned 3 (three) teaching staff of Liberal College, Luwangsangbam, the same of which will be counted as experience or service required for promotion or direct recruitment as the case may be from the date(s) of their joining as noted against each of them in Para 3(a) above. However, no arrear of Pay for the period from the date of their initial date of joining upto 21.02.2019 shall be claimed/ paid.

8. This issues with the concurrence of Finance Department (PIC) vide their U.O. No. 203/2021-2022/FD(PIC), dated 20.12.2021 & Department of Personnel vide U.O. No. 85/2021-2022/DP dated 31.12.2021.
