**ORDERS BY THE GOVERNOR : MANIPUR**

Imphal, the 15<sup>th</sup> June, 2022

**No. UHE-18030/1/2020-HTE-DHTE:** Whereas, consequent upon the taking over of Waikhom Mani Girls' College, Thoubal and 3 (three) other erstwhile Aided Colleges by the Government, the Administrative Department of Higher & Technical Education, Manipur had appointed Md. Ahmad Ali Shah, Waikhom Mani Girls' College, Thoubal as 'Lecturer in History' vide Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 wherein his date of joining is printed as **28.03.1981** as per the Verification report of the Verification Committee and with due concurrence of Finance Department (PIC),

2. Whereas, as per the re-verification report furnished by the Verification Committee, the status of the said incumbent was later rectified as 'Qualified' and, as such, appointed as 'Assistant Professor in History' vide Order No. 14(9)/8/2020-HE(MSSW)(Pt.) dated 22.08.2020 wherein his date of joining is also printed as **28.03.1981** with due concurrence of FD(PIC);

3. Whereas, the Director (Univ. & Hr. Edn.), Manipur vide letter No. 3/3-36/15-UHE(Pt-II)(Vol-IV) dated 16.03.2020 & DUHE-17/6/2021-DUHE-DU&HE dated 02.12.2021 had furnished a fresh re-verification report of the Verification Committee in respect of the aforementioned incumbent wherein it is stated that the Verification Committee had re-examined the documents, including initial Appointment letter & joining letter of the said incumbent, and that it was found that the said incumbent was appointed as 'Lecturer in History' vide Order dated 28.03.1983 and requested to correct/change the date of joining in respect of Md. Ahmad Ali Shah from 28.03.1981 to 28.03.1983;

4. And whereas, Finance Department (PIC) was moved for views/comments on the re-verification report of the Verification Committee and views of the Finance Department (PIC) is reproduced below:

"As per re-verification sheet/report of the Verification Committee, FD(PIC) agrees on the correction of the initial date of joining as 28.03.1983 instead of 28.03.1981 in the appointment order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 in respect of Md. Ahmad Ali Shah, Assistant Professor of Waikhom Mani Girls' College."

5. Now, therefore the Governor of Manipur is pleased to order the correction of initial date of joining in respect of Md. Ahmad Ali Shah, Assistant Professor in History, Waikhom Mani Girls' College, Thoubal as 28.03.1983 instead of 28.03.1981 in the appointment order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 read with Order No. 14(9)/8/2020-HE(MSSW)(Pt.) dated 22.08.2020.
