No. UHE-18010/6/2022-HTE-DHTE: Whereas, consequent upon the taking over of 4 (four) erstwhile Aided Colleges, including S. Kula Women's College, and its conversion into full-fledged Government Colleges, necessary verification in respect of staff of 4 (four) Aided Colleges were undertaken and Kh. Manao Singh of S. Kula Women's College was appointed as 'Lecturer in English' vide Government Order No. 14(9)/8/2020-HE(MSSW) dated 14.10.2021 in the pay scale of Rs. 9,300 - 34,800 + GP Rs.4400/- under 'Unqualified' category as per the report of the Verification Committee with due concurrence of Finance Department (PIC);

- 2. Whereas, the Director (Univ. & Hr. Edn.), Manipur vide letter No. DUHE-17/4/2021-DUHE-DU&HE dated 12.05.2022 had furnished a re-verification report of the Verification Committee in respect of the aforementioned incumbent wherein it is stated that he is found qualified as per 1989 RR as 1997 RR notified vide Order No. 1/10/67-RR/DP(Pt.) dated 15.01.1997 was kept in abeyance vide Order No. 1/10/67/RR/DP(Pt) dated 10.02.1998 thus reviving/enforcing the 1989 RR with effect from 26.02.1998 (date of publication in Gazette) till the 1998 RR was notified on 24.09.1998;
