**No. UHE-18010/1/2021-HTE-DHTE:** Whereas, consequent upon the taking over of Biramangol College, Sawombung and 5 (five) other erstwhile Aided Colleges and its conversion into a full-fledged Government Colleges, the Administrative Department of Higher & Technical Education had appointed A. Maheshwari Devi of Biramangol College as 'Assistant Professor in English' vide appointment order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 under the Category 'Unqualified (Approved)' Group in the Pay Scale Rs.15600-39100 + AGP Rs. 6000 with due concurrence of Finance Department (PIC);

Whereas, the Director, University & Higher Education, Manipur vide letter No. 3/3-36/15-UHE(Pt-I)(Vol. IV) dated 29.10.2020 had furnished a re-verification report of the Verification Committee regarding the rectification of status of qualification in respect of A.
