## **ORDERS BY THE GOVERNOR: MANIPUR**

Imphal, the 6th January, 2022

**No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.):** Whereas, consequent upon the taking over of 105 (one hundred and five) teaching & non-teaching staff of erstwhile 4 (four) Aided Colleges namely, i) Moreh College, Moreh ii) S. Kula Women's College, Nambol, iii) South East Manipur College, Komlathabi & iv) Waikhom Mani Girls' College, Thoubal by the Government vide Order No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.)(A) dated 22.06.2021, the Administrative Department had appointed 52 (fifty two) teaching & 43 (forty three) non-teaching staff of the erstwhile 4 (four) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(Pt.) dated 02.08.2021 with due concurrence of Finance Department (PIC);

- 2. and whereas, the Director (Univ. & Hr. Edn.), Manipur vide letter No. 3/3-36/15-UHE(Pt-I)(Vol-III) dated 10.03.2021 had furnished a fresh verification report of the Verification Committee wherein the service records of 6 (six) teaching & non-teaching staff of the aforementioned erstwhile Aided Colleges had been re-verified;
- and whereas, the aforementioned 6 teaching & non-teaching staff of the aforementioned erstwhile Aided Colleges were appointed vide Government order dated 02.08.2021 in their concerned subject, post & Colleges subject to the conditions as cited below:
  - "4. All the Lecturers who were not qualified under the relevant Government College Lecturer Recruitment Rules under UGC Regulation against the created/converted post shall be treated as Lecturer and they shall be considered in the Scale of PB-2: Rs. 9300 34,800/- plus GP of Rs. 4400/- p.m. till they get qualified as per the existing recruitment rules by giving them one time opportunity to improve their educational qualification to pursue either NET/M. Phil/Ph. D. Degrees as the case may be, as per relevant UGC norms within a period of 5 (five) years from the date of issue of order for conversion into full-fledged as done in the case of regularisation of 418 Part-time Lecturers vide Government order No.7(2)/9/2005-S/HE(Pt. III) dated 10.05.2016. After improving themselves upto their requisite educational qualification i.e. either M. Phil or NET or Ph. D. Degrees, they shall be entitled for the pay-scale of PB-3: Rs. 15,600-39,100 plus AGP of Rs.6000/- p.m. with the designation as Assistant Professors in parity with qualified Assistant Professors.

- 5. The Unqualified (unapproved) non-teaching staff shall be absorbed in a pay scale one stage lower to the prescribed scale till such time they are qualified as per relevant RRs."
- 4. and whereas, the matter was referred to the Finance Department (PIC) and concurrence of FD (PIC) has been obtained as cited below:

Further, the post of Office Assistant has been renamed as LDC vide Post creation order dated 22.06.2021. Therefore, in the absorption order dated 02.08.2021, the post of Office Assistant in respect of Shri Elangbam Kumar Singh may be corrected as LDC."

- 5. Now therefore, the Governor of Manipur is pleased to order the upgradation of the post of the aforementioned 6 teaching & non-teaching staff on having acquired the requisite educational qualification as detailed in Para 4 above.
- 6. Further, the post of Shri Elangbam Kumar Singh of Waikhom Mani Girls' College, Thoubal may be read as 'LDC' in place of 'Office Assistant' in the Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 02.08.2021, the same as concurred by Finance Department (PIC) as mentioned in Para 4 Above.

7. This issues with the concurrence of the Finance Department (PIC), Government of Manipur vide their UO No. 247/2021-2022/FD(PIC) dated 05.01.2022.
