RETIRED CHIEF JUSTICES AND RETIRED JUDGES OF THE HIGH COURT OF MANIPUR (ASSISTANCE AND FACILITIES) [AMENDMENT] RULES, 2024

In exercise of the Powers Conferred under Article 229 Clauses (1) & (2) of the Constitution of India, Hon'ble the Chief Justice of High Court of Manipur is pleased to make the following rules so as to amend the "Retired Chief Justices and Retired Judges of the High Court of Manipur (Assistance and Facilities) Rules, 2020".

- Short title and commencement:
 - (i) These Rules shall be called as "Retired Chief Justices and Retired Judges of the High Court of Manipur (Assistance and Facilities) [Amendment] Rules, 2024".
 - (ii) These Rules shall come into force with effect from the date of publication in the Official Gazette of Manipur.
- 2. The rate of the facilities/assistance provided under Rule 5 of the "Retired Chief Justices and Retired Judges of the High Court of Manipur (Assistance and Facilities) Rules, 2020" is revised as under:
