NOTIFICATION

Imphal, the 9th October, 2024

No.1/24/20-RR(DRDA)/DP: In supersession of all previous rules issued in this regard and in exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules regulating the method of recruitment to the post of **Assistant** in the Rural Development and Panchayati Raj Department (DRDA Wing), Manipur as shown in the MPSC Form-8, namely:

- Short Title:** These rules may be called the **Rural Development and Panchayati Raj Department - DRDA Wing (Assistant) Recruitment Rules, 2024.**
- Application:** These rules shall apply to the posts specified in column 1 of the M.P.S.C. Form-8 hereto annexed.
- Classification, Scale of pay, Method of Recruitment etc.:** Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in the columns 3 to 13 of the said MPSC Form-8.
- Disqualifications:**
 - No person, who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the aforesaid post, and
 - No woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said post.Provided that the Governor of Manipur may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

5. **“Power to Relax-** Where the Governor is of opinion that it is necessary or expedient so to do, he may order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons or posts.”

6. These rules shall come into force with effect from the date of publication in the Manipur Gazette.

RECRUITMENT RULES FOR THE POST OF ASSISTANT IN RURAL DEVELOPMENT &
PANCHAYATI RAJ DEPARTMENT (DRDA WING), MANIPUR

3.	Classification	G.C.S. Group-C (Non-ministerial)
4.	Scale of pay	Level-5 in the Pay Matrix (As prescribed in MS (RP) Rules, 2019)
5.	Whether selection or non-selection post	N.A.
6.	Age for direct recruits	38 (thirty eight) years & below (Upper age limit is relaxable for Govt. servants appointed under the Govt. of Manipur to the extent of the period of continuous services put in the post/service and by 5 years for SC/ST candidates and by 3 years for OBC candidates and a Govt. servant who belongs to SC/ST will get the facility admissible to a Govt. servant in addition to the relaxation admissible to SC/ST candidates). Relaxation of age shall be applicable to the candidate as per Govt. orders/OM etc. issued from time to time
7.	Educational and other qualification required for direct recruits	Essential : Graduate or its equivalent from a recognised University/Institute. Desirable : 1. Experience in file work in any Govt./PSUs or Govt. recognised establishment 2. Knowledge of Manipuri, Hindi & English
8.	Whether age and educational qualification prescribed for direct recruits will apply in the case of promotees	N.A.
9.	Period of probation, if any	2 (two) years
10.	Method of recruitment whether by direct recruit or by promotion or by deputation/transfer and percentage of the total sanctioned post to be filled by various methods	By direct recruitment

11.	In case of recruitment by promotion/ deputation/transfer, grades from which promotion/deputation/transfer to be made	N.A.
