No. 2/42/2022-Leg/L : The following Act of the Legislature, Manipur which received assent of the Governor of Manipur on July 31, 2022 is hereby published in the Manipur Gazette Extra-Ordinary:

**THE MANIPUR APPROPRIATION (NO. 5) ACT, 2022  
(Manipur Act No. 4 of 2022)**

An

Act

to provide for the authorization of appropriation moneys out of the Consolidated Fund of the State of Manipur to meet the amounts spent on certain services during the financial year ended on the 31<sup>st</sup> day of March, 2018 in excess of the amounts as granted for those services and for that year.

Be it enacted by the Legislature of Manipur in the Seventy Third Year of the Republic of India as follows:-

| 1. This Act may be called the Manipur appropriation (No. 5) Act, 2022.   | Short Title  |
| 2. From and out of the Consolidated Fund of the State of Manipur, the sums specified in column 3 of the Schedule amounting in the aggregate to the sum of four hundred sixty seven crore twenty lakh fifty six thousand rupees only shall be deemed to have been authorized to be paid and applied to meet the amount spent for defraying the charges in respect of the services specified in column 2 of the Schedule during the financial year ended on the 31 <sup>st</sup> day of March, 2018 in excess of the amounts granted for those services and for that year. | Issue of Rupees 467,20,56,000/- from and out of the Consolidated Fund of the State of Manipur to meet certain excess expenditure for the financial year ended on the 31 <sup>st</sup> March, 2018. |
| 3. The sums deemed to have been authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31 <sup>st</sup> day of March, 2018.   | Appropriation  |
