ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 17th September, 2024

No. UHE-1/8/2023-HTE-DHTE: Whereas, consequent upon the taking over of 4 (four) Aided Colleges namely, (1) Moreh College (MC), Moreh, (2) S. Kula Women's College (SKWC), Nambol, (3) South East Manipur College (SEMCO), Komlathabi and (4) Waikhom Mani Girls' College (WMGC), Thoubal and their conversion into full-fledged Government Colleges vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 29.01.2020, the Administrative Department had appointed 317 (three nundred and seventeen) numbers of teaching staff and 154 (one hundred and fifty four) numbers of non-teaching staff of the erstwhile 4 (four) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/8/2020-HE (MSSW) (Pt.) dated 22.08.2020 with due concurrence of Finance Department (PIC);

- 2. And whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE-2015/4/2023-DUHE-DU&HE dated 27.06.2023 & 29.09.2023 has furnished reports of the Verification Committee dated 27.06.2023 & 29.09.2023 on the re-verification of service records in respect of 3 (three) Teaching staff of Waikhom Mani Girls' College, Thoubal and S.K. Women's College, Nambol who were initially appointed as 'Assistant Professor' under the category Qualified (both Approved & Un-approved) staff at the time of taking over by the Government & Un-qualified (both Approved & Un-approved) staff at the time of taking over by the Government vide Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 1No. 14(9)/8/2020-HE (MSSW) (Pt.) dated 22.08.2020;
- 3. And whereas, the aforementioned 3 (three) Teaching staff mentioned at para 2 above as listed in the table below at para 5 have been appointed vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/8/2020-HE (MSSW) (Pt.) dated 22.08.2020 under the category Qualified (both Approved & Un-approved) staff at the time of taking over by the Government & Un-qualified (both Approved & Unapproved) staff at the time of taking over by the Government group without categorization of unqualified phase as Lecturer & qualified as Assistant Professor;
- 4. And whereas, after examination of the proposal for rectification of service records in respect of these 3 (three) Teaching staff, the matter was referred to Finance Department (PIC) for concurrence to the proposal of the Verification Committee and FD (PIC) has concurred to the rectification / changes in the date of qualification status in respect of these 3 (three) Teaching staff of the aforementioned 2 (two) newly converted Government Colleges;

5. Now, therefore, in partial modification of Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/8/2020-HE (MSSW) (Pt.) dated 22.08.2020, the Governor of Manipur is pleased to order the rectification / changes in the date of qualification status in respect of these 3 (three) Teaching staff of the aforementioned 2 (two) newly converted Government Colleges and the corrected list of staff along with their details as concurred by the Finance Department (PIC) in respect the 3 (three) Teaching staff are detailed in the Table below:

Further, it is ordered that the pay slips of the above teachers are to be rectified in consultation with the office of the Principal Accountant General (A&E), Manipur and any overdrawal of pay and allowances will be recovered or adjusted from the payable pay and allowances in equal monthly instalments within a period of 1 (one) year and full recovery from the retirement benefits in respect of those retired teachers.
