ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 17th September, 2024

No. UHE-101/75/2023-HTE-DHTE: Whereas, consequent upon the taking over of 6 Aided Colleges namely, (1) Biramangol College, Sawombung, (2) Kakching Khunou College, Kakching Khunou, (3) Liberal College, Luwangsangbam, (4) Mayai Lambi College, Yumnam Huidrom, (5) Standard College, Kongba & (6) Thambal Marik College, Oinam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 28.06.2018, the Administrative Department had appointed 478 (four hundred and seventy eight) numbers of teaching staff and 163 (one hundred and sixty three) numbers of non-teaching staff of the erstwhile 6 (six) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 & No. 14(9)/6/2019-HE(B) CONVSN dated 23.06.2021 with due concurrence of Finance Department (PIC);

- 2. And whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE-2015/6/2023-DUHE-DU&HE dated 06.07.2023 has furnished a report of the Verification Committee dated 27.06.2023 regarding the re-verification of service records in respect of 06 (six) teachers of Kakching Khunou College, Standard College and Biramangol College, Sawombung who were initially appointed as Assistant Professors under the category Qualified (both Approved & Un-approved) Staff at the time of initial appointment, Qualified (Un-approved) at the time of taking over and Qualified (both Approved & Un-approved) Staff at the time of taking over by the Government group vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 & No. 14(9)/6/2019-HE(B) CONVSN dated 23.06.2021;
- 3. And whereas, out of the aforementioned 06 (six) teachers at para 2 above, 04 (four) teaching staff as listed in the table below at para 5 have been appointed vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 & No. 14(9)/6/2019-HE(B) CONVSN dated 23.06.2021 with due concurrence of Finance Department (PIC) under the category Qualified (both Approved & Un-approved) Staff at the time of initial appointment, Qualified (Un-approved) at the time of taking over and Qualified (both Approved & Un-approved) Staff at the time of taking over by the Government group without categorization of unqualified phase as Lecturer & qualified phase as Assistant Professor;
- 4. And whereas, after examination of the proposal for rectification of the service records in respect of these 06 (six) teachers, the matter was referred to Finance Department (PIC) for concurrence to the proposal of the Verification Committee and FD (PIC) has concurred to the rectification of FD's earlier concurrence in connection with the appointment in respect of 04 (four) teaching staff of the aforementioned 03 (three) newly converted Government Colleges;

5. Now, therefore, in partial modification of Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 & No. 14(9)/6/2019-HE(B) CONVSN dated 23.06.2021, the Governor of Manipur is pleased to order the rectification of effective date of qualified/unqualified status in respect of 04 (four) teaching staff of the aforementioned 03 (three) erstwhile Government Aided Colleges now converted into full-fledged Government Colleges and the corrected list of staff along with their details as concurred by the Finance Department (PIC) in respect of the 04 (four) teaching staff are detailed in the Table below:

Further, it is ordered that the pay slips of the above teachers are to be rectified in consultation with the office of the Principal Accountant General (A&E), Manipur and any overdrawal of pay and allowances will be recovered or adjusted from the payable pay and allowances in equal monthly installments within a period of 1 (one) year and full recovery from the retirement benefits in respect of those retired teachers.
